# WELCOME MESSAGE

Good evening and welcome to the 2021 River Bend Association Annual Meeting. We wish we could meet with you in person, and appreciate your patience and participation.

Over the past 18 months, the River Bend Association (RBA) has tried to help keep everyone engaged and connected while we get through this pandemic. We celebrated Window Walks and Driveway Happy Hours that kept us safe and social. Neighbors helped neighbors with groceries and other needs with which loved ones far away could not help. Thanks to you, that is what makes this neighborhood an even better place to live.

In the 1960s and 1970s, this area we call River Bend was a part of St. Louis county with little cohesion and little resident participation in government. So the RBA was formed. As a government watch group and nucleus of the east side, west side, and historic homes along River Valley Drive, they identified the need for our area to become its own municipality. The RBA was born to protect our property values and rights. In 1988 that dream became reality, and the City of Chesterfield was chartered to include the four wards we know today; who all wanted the same protection, identity, and sense of community. The pool (now called the River Bend Community Center or "RBCC") was a place where all these groups socialized but required private membership.

We invite you continue the RBA tradition that continues to be the glue that keeps the residents, trustees, the RBCC and local governments on the same page.

# OUR MISSION

River Bend Association (RBA) is a non-profit, non-partisan organization. We are a separate organization from your Trustees and from the River Bend Community Center (RBCC). Our mission is to improve public services and living conditions within the River Bend community while protecting our property values. The RBA gathers and disseminates information on important local issues and events that impact our neighborhood. It also expresses the opinion of our members as needed to public officials on matters that relate to our community. We ask for your continued support by renewing your membership during our annual enrollment coming this October.

For only \$12.00 per year, the RBA provides you with our informational emails, an annually updated River Bend Directory, and a set of holiday luminaries to be set out on December 24<sup>th</sup>. ### HISTORY: WHY IS RBCC INDEPENDENT?

When Burton Duenke was building River Bend Estates in the fifties and sixties, it was a time when people were retreating from municipal pools to more private pools. He started building the River Bend Bath & Tennis Club (RBB&T) in 1963.

Rather than making it mandatory for all River Bend residents to join, he designed it to be a private club where a certain percentage of the membership could join from outside the neighborhood. Members had to buy a bond certificate in order to join the RBB&T. Those bonds were dissolved in the 1990s.

Since it had been the social nucleus of River Bend, the name was changed to River Bend Community Center in 2001. In 2006-2007, a group of residents tried to rally support to create a community improvement district (CID), where everyone in River Bend would become a member; this would finance a total re-build of the RBCC. While that was not successful, the pool continues today with an average of 120 private memberships, and sponsors many social events open to the neighborhood.

# CHESTERFIELD CITY COUNCIL REPORT

Dear Friends,

We would like to thank the River Bend Association for this opportunity to share some information about city business and what's going on in town.

In 2020 COVID 19 took a huge chunk out of City revenues. As you know, the city relies primarily on sales taxes to provide the services that we all count on like police, parks, public works and planning and zoning. With many businesses being forced to close during the pandemic and folks not going out, the city suffered an over 5 million dollar loss. Thanks to a fiscally conservative council and administration, the city was able to continue to make payments on its long term debt in spite of the revenue loss. However the City did have to furlough staff, close facilities and cancel activities. In the fall of 2020, the city received about 3.5 million in CARES Act funding from the federal government which helped plug some of the holes. In 2021, things began looking up with sales tax revenues finally beginning to improve. In the very near future, the city expects to receive around 9 million in RESCUE Act funding from the Feds. Parks activities including the pool, concerts at the Amphitheater, and CVAC athletic events have resumed. However, due to concerns about the Delta variant and liability issues, the City is following CDC guidelines so Council has gone back to Zoom meetings. The city is monitoring the situation.

As you may know, the city approved zoning for a Total Access Urgent Care for the Steak and Shake property. However Doctor Bruckel is no longer part of that organization and their site plan has not been finalized. Council also approved The Residences at Hog Hollow, a new subdivision for the old Chesterfield Manor nursing home site. Additionally the City got a free park, thanks to land on loan to us from Logan College. The Park facilities will be installed as grants are obtained.

Just recently, after the huge storm we had in June, the city public works department spent a month picking up tree limbs and debris all over town. This work was not planned or budgeted.... but it was the right thing to do. Also Council has been holding electronic sign requests to the ordinance standard height of 6 feet in locations near residential areas. This is especially important for Olive Blvd in Ward I where there are multiple churches and several small businesses that may erect such signs. Residents frequently remind us that they do not want Olive to become another Manchester Road.

We still have no real information as to the plans for Chesterfield Mall. Nothing has been submitted to the Planning Department. The Staenberg Group bought the property. This is the same company that largely developed Chesterfield Valley after the flood of 1993. Their latest project in Chesterfield is an entertainment venue called The District. It is transforming the Taubman outlet mall located on the same side of the highway as Top Golf and features an awesome upscale theater with capacity of up to 3,000 called The Factory. As you know, there are vacant Malls sitting all over this country, so we are very grateful that a reputable developer bought ours.
