**STUDENT MEMBERSHIP REMINDERS**

1. A current membership wristband must be worn at all times at the pool or tennis courts.
2. Student members may not bring guests to the pool or tennis courts.
3. Student members have no voting rights and, for purposes of voting, are not considered members of RBB&TC d/b/a River bend Community Center
4. Student members must obey all posted pool rules, and the instructions of lifeguards, pool employees and RBCC board members

**POOL OPERATING HOURS**

Under Saint Louis Country rules, the pool may only operate between Memorial Day and Labor Day weekends. When Parkway schools are not in session, we expect the pool to operate from 11:00 a.m. to 8:00 p.m. on Sunday, Tuesday, Wednesday and Thursday, and from 11:00 a.m. to 9:00 p.m. on Friday and Saturday. When Parkway schools are in session, we expect to maintain the same schedule except we will open at 4:00 p.m. on school days. The pool's days and hours of operations are subject to change to accommodate swim and dive team meets and practices, and special events. We will attempt to notify members of any modifications to the schedule through email and posted notices. Should we fail to meet our membership and fundraising goals for 2020, we may need to reduce the number of hours we operate.

**RELEASE, INDEMNIFICATION AND HOLD HARMLESS AGREEMENT AND ACKNOWLEDGEMENT**

In consideration of my acceptance as a student member of RBB&TC d/b/a River Bend Community Center (hereinafter referred to as the "RBCC") and the receipt of services and enjoyment of amenities inherent in such a membership, I hereby agree to release and discharge from liability arising from negligence the RBCC, its owners, directors, officers, employees, agents, volunteers, members and all other persons or entities acting for them (hereinafter referred to as "Releasees"), on behalf of myself and my children, parents, heirs, assigns, personal representative and estate, and also agrees as follows: 1. I acknowledge that the sport of swimming involves known and unanticipated risks which could result in physical or emotional injury, paralysis or permanent disability, death and property damage. Risks include, but are not limited to, death as a result of drowning or brain damage caused by near drowning; broken bones, torn ligaments or strains as a result of falls on the deck or from a diving board; medical conditions resulting from physical activity; and damaged clothing or property. I understand such risks simply cannot be eliminated, despite the use of safety equipment, without jeopardizing the essential qualities of the activity. 2. I expressly accept and assume all of the risks inherent in this activity or might have been caused by the negligence of the Releasees. My participation in this activity is purely voluntary and I elect to participate despite the risks. In addition, if at any time I believe the conditions are unsafe or that I am unable to participate due to physical or medical conditions, then I will immediately discontinue participation. 3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Releasees from any and all claims, demands, or causes of action which are in any way connected with my participation in this activity, or my use of the RBCC's equipment or facilities, arising from negligence. This release does not apply to claims arising from intentional conduct. Should Releasees or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs. 4. I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while participating in this activity, or else I agree to bear the costs of such injury or damage myself. I further represent that I have no medical or physical condition which could interfere with my safety in this activity, or else I am willing to assume – and bear the costs of – all risks that may be created, directly or indirectly, by any such condition. 5. In the event I file a law suit, I agree to do so solely in the State of Missouri, and I further agree that the substantive law of that state shall apply. 6. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect. By signing this document, I agree that if I am hurt or my property is damaged during my participation in this activity, then I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence. I have had sufficient time to read this entire document and, should I choose to do so, consult with legal counsel prior to signing. Also, I understand that this activity might not be made available to me or that the cost to engage in this activity would be significantly greater if I were to choose not to sign this release, and agree that the opportunity to participate at the stated cost in return for the execution of this release is a reasonable bargain.
