

### Sherri Vogt, Veterans Affairs Liaison, Hartford Health Care

Every day is veterans' day for Sherri Vogt, who has evolved a family legacy of military service into serving the military. A third-generation U.S. Army veteran who served during Desert Storm, Vogt is continuing her mission as the Hartford HealthCare veterans' liaison, connecting them with benefits, entitlements and services available, often ones they didn't even know existed.

Some of the ways Vogt helps veterans include:

Obtaining rightful medals, including the Connecticut Veterans Wartime Service Medal, those earned during service time, France's Knight of the Legion of Honor Medal and Korea's Ambassador of Peace Medal

Registering them at the National Museum of the U.S. Army, National Museum of the U.S. Navy, and/or WWII Registry of Remembrance

Assisting with end-of-life planning by providing information on burial options, free footstone and military honors; and obtaining burial allowances when eligible

Obtaining discharge papers (DD214)

Connecting to financial assistance when eligible

Discussing possible disability and "presumptive diseases" claims

"We know that when veterans are connected to the right resources, they have better overall health outcomes," said Carla Schnitzlein, DO, a veteran and provider with the Hartford HealthCare Behavioral Health Network. "The system can be challenging to navigate, especially if a veteran is struggling with depression, PTSD or other behavioral health concerns. It's so important to have a Battle Buddy like Sherri to make the process that much smoother and certainly less stressful."

Thank a veteran "I believe every day is Veterans Day," Vogt said. "We as an organization strive to honor, teach and embrace patients, families and veterans about benefits and connect to them to the appropriate resources."

Erika regularly gives school finance presentations to community and school groups, and offers a number of workshops for those interested in learning more about education funding and how they can increase their civic participation. In addition to trekking around the state, Erika is responsible for developing and executing the School and State Finance Project's community engagement plan, and for nurturing and maintaining connections in communities.

Erika is a former member of the Windham Town Council and has served as both a community representative on the Windham School Readiness Council and as a board member for the Windham Parent Network.

As a proud mother of four, Erika has experienced the gamut of Connecticut's public school systems. In addition to homeschooling for a period of time, her children have attended local public schools and magnet schools. The journey of her children through school, and her unique experiences as both a community leader and parent, have fueled her passion for working with communities to support their students and schools.

Erika's commitment to education and community is demonstrated through her past work assisting parents and guardians through special education Planning and Placement Teams (PPTs) and her founding of the Windham chapter of Blessings in a Backpack, a program that sends food home to roughly 500 Windham-area children each weekend.

Erika holds a Master of Education degree in Early Childhood Education from the University of Hartford and a Bachelor of General Studies degree from Eastern Connecticut State University. From 2000-2016, she also served as an adjunct professor at The Hartt School at the University of Hartford, where she led the nonprofit component for Performance Arts Management and Music Management majors.

Dana regularly provides multilingual legal representation in English, Spanish, French and Romanian. She also has a basic knowledge of Italian, German, Hungarian and Latin. She is often quoted by publications such as Bloomberg/BusinessWeek and the Hartford Business Journal on immigration law topics.

Dana is a member of the the firm's Inclusion and Diversity Council and assists with the firm's diversity and inclusion strategy and initiatives, ensuring that the firm's core principles of inclusiveness and diversity are reflected across its internal and external policies, work and practices.

In addition, Dana handles a variety of cases to assist immigrants and refugees with humanitarian legal needs. Examples of humanitarian cases she assisted with include:

- Representing Muslim refugee and her three children at JFK airport during the promulgation of the Muslim Ban in January 2017.
- Representing Cuban nationals with habeas corpus release from ICE custody in 2018 and 2019.
- Representing 70 Afghan nationals in applying for humanitarian parole after the U.S. withdrawal from Afghanistan
- Representing several immigrants from various countries in applying for asylum based on political, religious and ethnic persecution.
- Traveling to the Tijuana San Diego border checkpoint to assist more than 2,000 Ukrainian refugees entering the United States on humanitarian parole.
- Setting up the "Connecticut for Ukraine" Matching Program which matches Ukrainian refugees to Connecticut sponsors.
- As Honorary Consul of Romania to Connecticut, running diplomatic programs that assisted the reunification of families separated at the border (Roma populations), coordinating assistance for vulnerable Romanian citizens in Connecticut and assisting in the transfer of Ukrainian refugees from Romania to Connecticut.
- Advocating for pro-immigrant bills at the state and federal level and offering testimony in support of state bills protecting the rights of Connecticut immigrants.
