

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.phoenixreclamationproject.org and Phoenix Reclamation Project and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Phoenix Reclamation Project include www.phoenixreclamationproject.org and The Phoenix Reclamation Project. The The Phoenix Reclamation Project website is a Nonprofit Organization site. By using the The Phoenix Reclamation Project website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, The Phoenix Reclamation Project may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase The Phoenix Reclamation Project's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. Use of your Personal Information

The Phoenix Reclamation Project collects and uses your personal information to operate its website(s) and deliver the services you have requested.

The Phoenix Reclamation Project may also use your personally identifiable information to inform you of other products or services available from The Phoenix Reclamation Project and its affiliates.

Sharing Information with Third Parties

The Phoenix Reclamation Project does not sell, rent or lease its customer lists to third parties.

The Phoenix Reclamation Project may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to The Phoenix Reclamation Project, and they are required to maintain the confidentiality of your information.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by The Phoenix Reclamation Project. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the The Phoenix Reclamation Project website.

Use of Cookies

- SSL Protocol

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
