Message from our Executive Director and Board Chair

It's through dedication from the whole Dundas County Hospice family that we have made it this far and will continue to go further than maybe we even think possible. We each saw our share of struggles this year. It's hard to get through life without illness and loss touching you, and sometimes we forget that the helpers sometimes need help too.

Together we have been able to provide comfort, relief and security to not only our clients and their families, but to each other as well. Whether it is in the form of a listening ear, equipment loan, or hospice services, the hospice is here to support everyone, particularly when it is one of our own. We may be here to serve our community, but we don't forget that we are part of that community as well.

Our team of dedicated volunteers have been walking this road with us every step of the way. This year they have taken almost 400 combined hours of education courses in palliative care, grief and bereavement, many other topics, continuing to gain valuable knowledge and new skills to better serve our community. They bring this new knowledge with them to every client they visit and every life they touch.

Creating a stronger friendship and sense of community among our volunteers has been an important goal for volunteer retention and ensuring our volunteers feel engaged with the hospice and our community throughout the year. It takes a special type of person to be a hospice volunteer, and we are thankful for each one of them.

Our board of directors are another group of volunteers who help Dundas County Hospice to go far. Their dedication to not only the guidance and oversight of the hospice, but also their support and determination when it comes to the running of programs, fundraisers, and the ground-level, day-to-day work of the hospice. Not all heroes wear capes. In the last year our board has been lucky to find new support in the form of Marc Gervais and Christine Thom. These new additions will bring a different perspective, insight and a fresh sense of enthusiasm that is always welcome at the boardroom table.

Funding is always a concern for a non-profit. Having space to grow and the means to do it, is vital, particularly in the ever-expanding field of health care. Our fundraising efforts raised over \$180,000 in donations and sponsorship in the last year and continue to expand the presence of Dundas County Hospice in the community. Our ambassadors and board members spent countless hours in preparation and presentation to various groups including the 100 Men and Women of both North and South Dundas to high success. Our grant writing has been extensive this past year, and though the process is much slower, we are seeing good results from those efforts as well.

Programming at Dundas County Hospice has always been client centered. That was our main focus in the last year as we installed a new program—the Men's Shed. Men experience grief differently from women and , as such, need a different type of support in their grief. Our Men's Shed, while still a work in progress, strives to be a place where men can come together to find kinship, support and community. They will build, create, repair and grow together, connected by their loss, but supported by each other and our G&B group facilitators. Our Grief Support Group and Grief Book Club continue to assist those struggling with loss in our community. Of course our Day Program continues to be a valuable resource for people living with a life-threatening illness as well as their caregivers. Our Equipment Loan Program has helped 262 community and palliative clients to stay safe in their homes whether it is due to an injury, surgery, or declining mobility.

From humble beginnings, Dundas County Hospice has risen into a pillar of support for our community and each year that passes sees that pillar grow stronger. This isn't something that can happen overnight, and it surely can't happen without a strong community willing to back it up. So, as we look forward to the next year and all the future years, we must remember that we didn't start alone and if we want to keep going and go far, we have to do it together. Volunteers, staff, and all of North and South Dundas—together.
