Mr. Sigurdsson attended the council meeting. Mr. Sigurdsson had the following concerns: Safety Concerns where Birchy Drive is not wide enough for two vehicles, no parking space, and no public washrooms.

Letter from Tom & Vicki Brake objecting to the proposed paintball business at 6 Birchy Drive. Mr. & Mrs. Brake were concerned: Site lacks basic infrastructure, including public washrooms. The field has been set up without council approval and is being used unsupervised. Birchy Drive is a narrow, steep dirt road with limited parking. Increased traffic will worsen road conditions, create safety hazards, and make access difficult for residents.

Email from Stephen Clarke, requesting permission to open Coastal Paintball at 6 Birchy Drive, Mount Moriah, in a field behind his house. The business will be a jelly ball field, where kids can play and have fun. There is netting around the field, and the proper safety signs. Jelly balls are biodegradable and not bad for the environment, and they pose no danger.

There was a lengthy discussion regarding setting up this business at 6 Birchy Drive, Mount Moriah.

Mayor Duffney asked three times if anyone would like to make a resolution to approve Stephen Clarke's request to set up a business, Coast Paintball, at 6 Birchy Drive, Mt. Moriah. There was no resolution made.

Mayor Duffney then proceeded to ask if anyone would like to make a resolution to disapprove of Stephen Clarke's request to set up a business, Coastal Paintball, at 6 Birchy Drive, Mt. Moriah. 2025-122 Hamlyn/Butt
