Mr. Batt is waiting on Eco Contracting to get the electrical plans for the Fire Hall to see what needs to be done in there, to try and rectify the problem of high electrical bills.

The council will have to decide what piece of equipment they want to apply for under Active NL. There was some discussion regarding a piece of equipment for children with autism.

Mr. Paul Wylezol, Chairperson, Cabox Aspiring Geopark, can attend a public meeting to discuss their application for crown land for a walking trail in the Cook's Brook area. The council will check to see if Mr. Wylezol is available for the meeting on Wednesday, May 22 or 29, 2024 at 7:00 p.m.

The Water Distribution Basics course that the maintenance men need to do will not be offered in the Corner Brook area until November 2024.

The Town Clerk/Manager, Carol Skeard, informed the council that she spoke to Newco Metal regarding the planer on Serpentine Road. The request to pick up the planer will be sent tomorrow to Newco Metal.

Pest Control has been down to service the old fire hall.

Public Concerns

Mr. Jason Banfield attended the council meeting to discuss the ditch on Murley's Drive. Mr. Banfield pointed out that the ditch above his property needs to be dug out as the ditch is filled in and there is no ditch beyond his property on Murley's Drive. The council will get ditching done on Murley's Drive on the left-hand side going down Murley's Drive. Discussed the top of Murley's Drive, concrete needs to be repaired. Discussed Park Lane the gravel washing down from Park Lane and filling in the gutter on Main Street.

The council will send a letter to Mr. Tyson Murley informing him that he needs to put a culvert in the front of his garage and house at 5-9 Murley's Drive.

The railway bed needs to be filled in where it washed out onto MacDonald Drive.

Email from Doug Butt regarding the status of the water issue they are having from water runoff from Upper Soper's Drive running down on their property on MacDonald Drive. Mr. Butt attended the council meeting. Councilor Brad Porter and Council Brad Penney looked at this section of Soper's Drive and the trailway bed to see how the water could be diverted from running down onto properties on MacDonald Drive. Councilor Porter and Councilor Penney will explain to maintenance men Kyle Specker and Paul Murley what needs to be done in this area so the water does not run down on the residence of MacDonald Drive.

Tina Saunders and Rodney Seymore said they had to call the RNC regarding rooster crowing because the Town by-laws clearly state that the Town Council will not be enforcing anything. Even though it is going against the noise by-law imposed by the council. Why have by-laws in place if the council is not going to enforce them, just a waste of words. But in saying that we were told by the RNC that the Town has to be the one to call on this person and bring it to civil court and she can be fined up to \$500 for continuing with this issue. If this is not done, we as residents can take the Town Council to court for failure to do their due diligence in this matter. Again, going against the noise by-laws, if these persons are getting away with it, others will follow and before you know it there will be no need to have by-laws in place for anything. According to the Town's Development Regulations, the Town of Mount Moriah does not become involved by virtue of these Development Regulations where pets are presenting dangers or nuisances to others, or are not properly housed or not given appropriate care. In those cases, regulations concerning public health, public safety, running at large, cruelty to animals, noise and other such matters better enable authorities to deal with offending behavior. The council will send the residents at 109 Main Street another letter asking them to abide by the Town of Mount Moriah Nuisance Regulations.
