

# A COMMUNITY WILDFIRE PROTECTION PLAN



## FOR RURAL FIRE DISTRICTS AND TRIBAL COMMUNITIES IN COCONINO COUNTY

### BACKGROUND

The Greater Flagstaff Forests Partnership (GFFP), a nonprofit since 1996, was awarded a Community Wildfire Defense Grant to develop a novel Community Wildfire Protection Plan (CWPP) for nine fire districts and six tribal communities in rural Coconino County.

### GFFP AND COCONINO COUNTY RECOGNIZE THE PROBLEM AND THE SOLUTION

Coconino County acknowledges wildfire and post-wildfire flooding as the top public safety threat, having endured nine major wildfires and over 255,000 acres burned since 2010. The County has higher wildfire risk to homes than 84.5% of U.S. counties. Given this threat, this CWPP will provide local solutions to reduce the risk of wildfire across the County.

Existing CWPPs are outdated or limited to urban areas, excluding many rural and tribal communities. To address this, this new CWPP will include both incorporated and unincorporated areas, providing local solutions to reduce wildfire risk and strengthen community resilience.

## THE CWPP PROCESS

The CWPP process will involve public input to guide fuels management planning and wildfire risk reduction for rural communities across Coconino County. **Specifically, the CWPP will produce separate analyses for each of the communities, including a community-based "Action Plan" to implement prioritized on-the-ground fuel reduction projects for highly valued community resources and assets.**

The CWPP, expected by June 2026 and is overseen by GFFP, Coconino County, SWCA Environmental Consultants, and a Core Team of diverse agency and community representatives. Fire districts and tribal leaders will play key roles in prioritizing treatments, identifying valued resources, and maintaining the Action Plan.

## WHAT ARE THE BENEFITS OF THE CWPP PROCESS?

1. Create Community Risk Assessment and Recommendations
2. Plan Landscape Scale Wildfire Mitigation Measures
3. Increased Capacity and Resources
4. Create an Actionable, Fundable Plan
5. Deliver a Community-Supported Plan

## HOW WILL THE INFORMATION BE SHARED AND PROTECTED?

The completed CWPP will be available on the project's website, featuring an ArcGIS Hub and an easy to navigate StoryMap. The website will contain all information and tools needed to complete, understand, and update this CWPP. While most data used will be publicly sourced, sensitive tribal data will be protected and not shared.
