Many Religious 'Nones' Around the World Hold Spiritual Beliefs

Around the world, many people who do not identify with any religion nevertheless hold a variety of spiritual and religious beliefs, including the belief that there is life after death, according to a Pew Research Center study of religiously unaffiliated adults in 22 countries.

The number of adults who are religiously unaffiliated – describing themselves as atheist, agnostic or "nothing in particular" – has <u>climbed rapidly in the recent past</u> across North America, Europe, parts of Latin America and some countries in the Asia-Pacific region, such as Australia and South Korea.

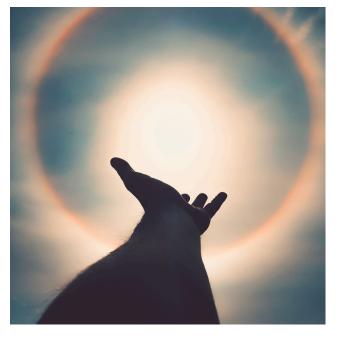
In general, religiously unaffiliated people are less likely to hold spiritual beliefs, less likely to engage in religious practices, and more likely to take a skeptical view of religion's impact on society than are Christians, Muslims and people who identify with other religions.

But sizable percentages of religiously unaffiliated adults - often called religious "nones" - do hold some religious or spiritual beliefs, according to our nationally representative surveys of 22 countries with relatively large unaffiliated populations.

Many Americans who generally distrust national news organizations still express trust in certain outlets

Pew Research Center has long asked Americans how much they <u>trust information from national news organizations</u> in general. Recently, we asked about their trust in <u>30 specific news sources</u>.

It's not surprising that people who trust national news organizations are more likely than those who distrust them to say they trust most of the 30 sources we asked about. But several news sources with right-leaning audiences are exceptions to this pattern, according to a new Center analysis that combines these general and specific measures of trust in the media.

This analysis helps answer the question: What news sources are Americans thinking of when they say they trust or distrust the information they get from national news organizations?

For U.S. adults who have at least some trust in the information they get from national news organizations, the answer most often seems to be major national TV sources. Within this group of "trusters," about half or more say they trust ABC News (56%), NBC News (56%), CBS News (51%), CNN (51%) or PBS (51%). These are some of the most widely known and popular news sources we asked about.

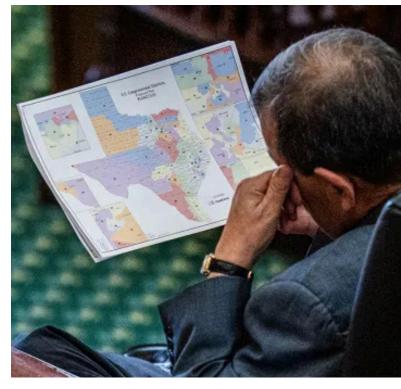
Redistricting between censuses has been rare in the modern era

Texas Republicans, at the urging of President Donald Trump, have <u>redrawn their state's congressional districts</u> to give the GOP an advantage in next year's midterm elections. The effort has led to a <u>countermove by California</u> to redraw its districts to give Democrats an edge. Several other states reportedly are considering <u>similar moves</u>.

Midcycle redistricting efforts like the ones in Texas and California have, up to now, been extremely uncommon. Since 1970, only two states – Texas in 2003 and this year, and Georgia in 2005 – have voluntarily redrawn their congressional maps between censuses for partisan advantage, according to a new Pew Research Center analysis.

When midcycle redistricting occurs, it's usually because courts have thrown out the previous maps for violating state or federal law. In fact, 36 of the 40 midcycle redistricting changes since 1970 have either been made in response to a court order (20) or imposed by a court itself (16). In addition to Texas and Georgia, California is also an exception: After the 1982 elections, lawmakers passed a revised version of the congressional map that voters had rejected in a referendum earlier that year.

Women ministers resist misogyny with mentors, training, resilience, study finds

With a total of six decades of ministry between them, the Revs. Liz Ríos and Liz Mosbo VerHage were not surprised to learn that the vast majority of women ministers have faced misogyny.

But their <u>new report</u>, "Empowering Resilient Women Ministers: Unveiling the Fuel to Serve Amidst Misogyny," revealed what helped keep their colleagues in the ministry. Across ages, races and denominations, women cited pursuing the call they believe they've received from God, supportive networks and perseverance as top contributors to their success.

The research by Ríos and VerHage, both ministers and scholars, revealed that 87% of the 610 women they surveyed said they experienced misogyny, defined as "discrimination, prejudice, objectification, or violence based on your gender," in their ministry context. Forty-seven percent said they experience such discrimination regularly.

Pentagon authorizes up to 600 military lawyers to serve as temporary immigration judges

Defense Secretary <u>Pete Hegseth</u> has approved sending up to 600 military lawyers to the Justice Department to serve as temporary immigration judges, according to a memo reviewed by The Associated Press.

The military will begin sending groups of 150 attorneys — both military and civilians — to the Justice Department "as soon as practicable," and the military services should have the first round of people identified by next week, according to the Aug. 27 memo.

The effort comes as the Trump administration more regularly turns to the military as it <u>cracks down on illegal immigration</u> through ramped-up arrests and <u>deportations</u>. Its growing role in the push includes <u>troops patrolling the U.S.-Mexico border</u>, National <u>Guard members being sent into U.S. cities</u> to support immigration enforcement efforts, housing people awaiting <u>deportation on military bases</u> and <u>using military aircraft</u> to carry out deportations.

The administration's focus on illegal immigration has added strain to the immigration courts, which were already dealing with a massive backlog of roughly 3.5 million cases that has ballooned in recent years. An organization for immigration lawyers called the new directive a "destructive" move meant to undermine the courts.

Majorities of adults see decline of union membership as bad for the U.S. and working people



Majorities of Americans see the large reduction in the share of workers represented by unions over the past several decades as a bad thing for both the United States and its working people.

- 60% of U.S. adults say the decline has been bad for the country.
- 62% say this has been bad for working people.

The share of U.S. workers who belong to a union has fallen since 1983, when <u>20.1% were union members</u>. In 2024, <u>9.9% of U.S. workers were in a union</u>.

Since Pew Research Center first asked these questions in 2021, majorities of adults have consistently said that the decline in union membership has been bad for both working people and the country.

The share of Americans who say this has been bad for the country is up 6 percentage points since last year (from 54%). The increase has come entirely among Democrats and Democratic-leaning independents:

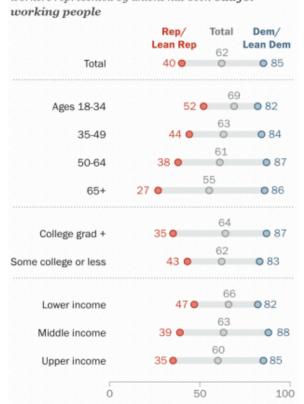
- Today, 82% of Democrats say this decline has been bad for the country, up from 69% who said this a year ago.
- 85% of Democrats also say the decline in union membership has been bad for working people, up from 74% in 2024.

By contrast, majorities of Republicans and GOP leaners continue to say that the decline in union membership has been good for the country (62%) and for working people (59%).

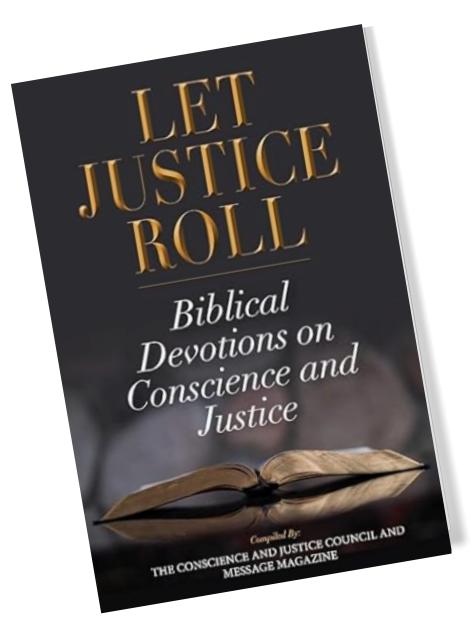
