- 1. In the absence of President Bialecki, the meeting was called to order at 10:02AM by Vice-President Steve Heimerman.
- 2. Motion by Tober/Mott to approve the agenda as presented. Motion Carried.
- 3. FIA Items: Kaiser passed out the proposed 2025/2026 budget for all Forestry Projects including the newly awarded Michigan UP Plots and his recommendations for plot prices for the 2025-2026, 2nd panel of this current contract. He answered questions and explained that the overall increase is consistent with inflation. The committee requested that they be given a profit & loss statement for the prior year along with the proposed budget for the coming year. Beckman will send them that spreadsheet.

- 5. SIMPLE PLAN Discussion In July of 2024, the Executive Committee approved employee IRA contributions be increased from 3% to 5%. After the vote, Beckman learned that SIMPLE Plan laws only allow for 3% employer contributions. Beckman discussed options with our financial representative Ryan Hetland who explained we could choose to do up to a 2% non-elective contribution as long as we update our Federal Form 5304-SIMPLE showing we're adjusting the plan to include this change to be paid before 4/15/2026. Beckman will then notify employees by 11/1/2025 about the plan changes and that they have 60 days to make any other personal plan changes before the changes go into effect on 1/1/2026.
- 6. Council grant voting policy discussion the committee agreed to change some verbiage to make the policy terms more consistent.
- 7. County LWCC Role in grant process discussion the committee agreed that this part of the policy should be made clearer. Beckman will work on both updates and present them for a vote at the Jan 2026 meeting.
