Mission Statement: Lumberjack Resource Conservation & Development Council, Inc., a multi-county, nonprofit in Northeastern WI, strives to enhance area natural resources, promote a higher standard of living and improve the quality of life for area citizens by fostering partnerships between public and private sectors and strategically investing in area natural resources.

SUMMARY:

Answer: This project aligns on several levels. First, there are no public fishing piers on Town Line Lake and this project would enhance the natural resource by giving two more safe recreational opportunities for the lake: a safe ADA-compliant canoe/kayak launch and a safe ADA-compliant fishing pier. Second, Town Line is a small lake and perfect for canoeing/kayaking, but the landing is rocky, has areas with debris and is unlevel. Giving those with disabilities or limitations the opportunity to launch and fish safely on a smaller, less crowded lake would add immensely to their quality of life. Third, our group, Friends of Town Line Lake Park (FTLLP) has already fostered both public and private partnerships including the Oneida Co Bike & Walking Trails Council, Rhinelander Area Silent Trails Association, Northern Paddle Club, Newbold Outdoor Recreation Committee, Oneida County Forestry Department and Committee, WDNR, Oneida County Land/Water Conservation. We have also moved several area corporate foundations to strategically invest in our project by helping them see our vision that this pier and launch is a fantastic way to strategically invest in our area natural resources because it would bring more people to our area. For these reasons, our project aligns well with your mission.

OBJECTIVES:

What problems, concerns or opportunities will this project address? You will be asked to show how your objectives were met when you present your follow-up presentation to the Council.

Answer: There are very few natural parks left like Town Line Lake Park so this project creates a huge opportunity to enhance the resources at this natural serene lake, just a mile from town. Also, there are NO ADA-compliant amenities at Town Line Lake Park, in fact there are NO ADA-compliant kayak launches in Oneida County, this would be the first one. This park would be perfect for the kayak launch because it is a small lake with little current so kayakers can take full advantage of wildlife viewing. They'll see heron, eagles, otters, loons, deer, songbirds, and be able to fish for crappie, blue-gill, perch, large-mouth bass, and the occasional northern if you're lucky. As described above, there is currently only shore fishing and with an uneven shoreline, it can be dangerous. A safe fishing pier would alleviate concerns for those with disabilities or those unsteady and allow them the freedom to fish a great, healthy lake. Another concern is the unsafe boat launch for canoes/kayaks. There is not a good level spot to launch and there is debris in area. Providing an ADA-compliant, safe, secure, and accessible launch would provide the opportunity for more people to recreate on the lake. At the end of the application are a rendering and a quote. Our budget also includes two signs. Following current signage statutes, we will place two interpretive signs at the head of the path and then at the gangway or on the pier. Our hope with the interpretive signs is to create

excitement and an overall Town Line Lake Park experience by highlighting the healthy ecology of the lake and drawing on the need for

serene recreational spots.

We are often asked why we are raising funds to care for and improve a county park that should be paid for with tax dollars. Even though this is a public park owned by Oneida County, in 2020 they were finalizing plans to sell the most desirable portions of the park to offset the cost of another property slated for public use. With the other parks the county funds, there was nothing left to care for Town Line Lake Park so they chose to divest and then sell. Town Line Lake Park has been a county park for more than 100 years and holds historic and generational ties to the community. The community spoke up and made it known they wanted to keep this park. Our group Friends of Town Line Lake Park formed to stop the sale. Because of our efforts, in May of 2021 something historic happened at the Oneida County Board Meeting. Every member of the Oneida County Forestry & Recreation Committee voted against their own resolution to sell the park and joined every other county board member in a unanimous vote to keep historic Town Line Lake Park! Even though the park sale was stopped, the board made it clear that didn't mean there would be any budgeted funds to maintain or improve it. There came the understanding that any



improvements/amenities for the near future would have to be sought outside of the county budget so now FTLLP has a contract with the County stating we will maintain the park and fundraise for any improvements. Above is a picture showing how our efforts paid off in the summer/fall of 2022. With generous community support, we were able to raise enough money to place picnic tables, trash cans and porta pots for the first time in over a decade. Eventually we hope to establish enough use to show the county that their budget should include this park. In the meantime, we have successfully engaged the community and are looking forward to installing the first of its kind in Oneida County, kayak launch in combination with a fishing pier – see attached rendering.

FORMULATION & EVALUATION:


Why is this project the best way to address the issues described above? How will the outcome be evaluated? Be specific – outcomes that can be measured are viewed more favorably.

Answer: Combining the fishing pier/kayak launch is more efficient than trying to build one of each. There currently are no ADA-compliant kayak launches in Oneida county and no amenities at Town Line Lake Park so installation in the Spring of 2023 will be the most measurable outcome. It would also create better accessibility for all. Our group understands the importance of public engagement and will survey the users. Other outcomes will be measured by documenting pier/launch use post-installation.

ASSISTANCE NEEDED:

Why is assistance needed from Lumberjack? Who within your organization will run the project? Describe the assistance you are receiving from other partners. Include Letters of Support as outlined in Lumberjack's Granting Policy.

Answer: Our group organized in February of 2021, incorporated on 6/23/2021, received WI Charitable status on 7/22/2021 and IRS 501c3 status on 11/30/2021. We have a diverse board of directors with the skills needed to organize and implement projects. David Schmitz is the current chairperson of our fundraising committee and is the contact person for this grant. He will lead the other members of our board, along with community help, in following through with this project. Because we are a small, newly formed group, we are coming to Lumberjack because it is one of the few organizations that helps smaller groups with projects such as this. At the end of August 2022, the FTLLP started fundraising efforts. Since then, we've received generous donations totaling \$20,872 (please see budget sheet.) The FTLLP Board of Directors is committing another \$1,500 toward this project. The Oneida County Forestry Department has agreed to help with some initial maintenance at the site and to remove any over-winter items to shore. Supporting us with grants and donations are The Rhinelander Community Foundation, GBU Life Matching Funds Program,



Walmart Foundation, Nicolet National Foundation and WPS Foundation. In addition, we've raised a significant sum through events, online donations & jug donations (see picture above of our board at Oktoberfest in Rhinelander in September of 2022.) We are asking the

Lumberjack Council for a \$10,000 grant. The Council would reap almost immediate benefit by funding this project because with the combined donations, we would be able to form installation plans as soon as February 2023, grade the path as soon as weather permits in the Spring and install the pier by Mid-May 2023. With your donation, we'd be able to come back to your October 2023 meeting and present our 1st season's usage figures.





MINUTES – FTLLP BOARD MEETING

FTLLP Board – THURSDAY 8/4/2022 at 5:40PM At Town Line Lake Park & VIA ZOOM

Present: Follenweider, DeMent, Beckman, Schramke, Casey, Schmitz

Excused: Walters, Scheel, Belliveau

Tasks: Follenweider DeMent Beckman Schramke Casey Schmitz

- 1. Call to Order The meeting was called to order at 5:50pm by Follendweider
- 2. Review/Vote to Approve the Agenda Motion by Casey/DeMent to approve the agenda as presented. Motion Carried.
- 3. Review/Vote to Approve Minutes of the 7/14/2022 meeting Motion by Beckman/Schmitz to approve the minutes with noted corrections. Motion Carried.
- 4. Treasurer's Report Members reviewed the financial report which shows a checking balance of \$6,265.35 with restricted funds of \$2,448.51. Regarding restricted funds, noted that there is a difference between 'restricted' and 'earmarked'. Beckman will adjust the financial report to reflect restricted funds and earmarked funds for the next meeting. Motion by Casey/DeMent to approve the financial report with corrections. Motion Carried.
- 5. Public Input there was no public input
- 6. Trails Update Schmitz said nothing new to report, but he suggested that we connect a trail from Towline Lake Park to Forest Loop Road. Follenweider/Beckman move to approve pursuing this trail. Motion Carried. Schmitz & DeMent will follow up with Forestry to either ask Fiene if ok or have it put on the next committee mtg agenda.
- 7. Events Update Oktoberfest 9/10/2022 Beckman explained she paid for a booth at the upcoming event and will donate it to the group if they agree. We could solicit members and pier donations. The group agreed to attend, and Beckman will let everyone know the times. We'll also bring branded items which is an agenda topic later.
- 8. Updates/Schedules for mowing, clean up, trash pickup, porta pot cleaning, trash can signs, etc. Schramke continues to provide most of this work. Trash Schedule: 8/24 Rusty, 8/31 Paul, 9/7 Rusty. There is someone dumping a bag of trash once a week. If it becomes more of an issue, we'll attempt to learn their identity. Noted that the threat of oak wilt has passed, and Forestry is going to cut the compromised trees in the park. Park Clean Up Rusty will ask Taylor Prott to help him load raked piles into the back up his pickup and spread them in the woods at the park. Noted that in September we'll need to schedule leaf pickup, so this fall's leaves are picked up before the snow flies. One idea is to ask Elliot Boyer to help with this.
- 9. Picnic Tables frame update: There is a local company that sells picnic table frames \$179. The green treated wood and galvanized hardware would be around \$75 for a total of around \$260 for a picnic table. Follenweider/Schramke moved that DeMent pursue getting approval from Forestry for us to place these picnic tables. Motion Carried.

10. County Forestry Committee

- Update from 8/3 meeting Beckman attended and gave a report to the committee. Paul Fiene had nothing to add and thanked the group for their hard work stating it's looking "really good over there."
- Discuss Memorial Trees at Park for approval at Forestry's September meeting Linda Casey would like to plant a tree in memory of her son, so Beckman has asked that this item be put on the September committee agenda for approval. It was thought that Fiene may be able to approve this on his own, so we'll ask. Follenweider feels it could be a program sponsored by FoTLLP where people could donate the tree and we'd have a ceremony. We'd need to know how many trees and what type we can plant. While this program is being pursued, Beckman will find out about the one memorial tree for Linda's son.
- Items to discuss with Fiene or to be put on the 9/7 Forestry Committee Agenda: 1) Memorial Trees permission to plant but need type & how many are allowed (Beckman.) 2) Connected trail from the park to Forest Loop Road (Schmitz & DeMent) 3) Authorization to place \$260 picnic tables (DeMent)

11. Fund Raising Committee

 Meeting Recap – Schmitz reported that Casey is going to get some donation jars at area businesses and the label would contain the QR code. Casey will talk to Trig's about the requirements/rules for using their fundraiser booth. There are four members currently signed up that are being reimbursed up to \$150/person up to \$1,000 from GBU. J. Beckman, DeMent & Follenweider will sign up, so we earn the rest of the \$1,000.



- Demonstrate donation platform Follenweider demonstrated the platform and Beckman emailed the code to Casey so she can use it for the donation jars. This QR Code connects to the webpage with our pier fundraiser.
- Pier Fundraiser Update Beckman
 - i. FTLLP Board \$ Commitment Schramke/DeMent moved to approve \$1,500 from unrestricted funds be placed in restricted funds for the pier. Motion Carried.
 - ii. Budget Beckman referred to the budget handout that lists those organizations/businesses that have been or will be approached for grants. The total budget is \$55,258. Since we already have a commitment for \$1,500 from FTLLP, \$1,258 from Crandon Docks & \$5,000 from the Rhinelander Community Foundation, and the Lumberjack grant for \$10K is a pretty sure thing, the amount of the fundraiser will be \$45,000.
 - iii. Motion by Casey/Schramke to approve \$73 plus tax/shipping be placed in earmarked funds for the purchase or a goal thermometer. Motion Carried.

12. Membership
