NEW ORGANIZATIONAL STRUCTURE PROPOSED BY CHURCH COUNCIL

On September 26 the Church Council voted to seek approval from our District Superintendent, Melissa Rynders, to present the following resolution for organizational change from the current church structure to a simplified, accountable governance structure. (One Board model). A decision on whether or not to adapt this new structure will be made at our Church Conference scheduled for October 22, 2023. The Church Council has been in a period of discernment for most of 2023 to decide if this model will best serve Cross in the Desert into the future. The council members have studied the model, held robust discussions, and facilitated open information sessions to educate and get feedback from the congregation. A Frequently Asked Questions document can be found elsewhere in the Oasis to provide you will more information on how business will look if we adapt this model. I encourage everyone to join us on October 22nd to be part of this historic decision for the life of Cross in the Desert.

PROPOSED RESOLUTION TO CHANGE CONGREGATIONAL ORGANIZATION PLAN TO SIMPLIFIED, ACCOUNTABLE GOVERNANCE STRUCTURE

WHEREAS, ¶247.2 of the 2016 Book of Discipline for the United Methodist Church allows alternative models of governance; and

WHEREAS, the simplified, accountable leadership structure is utilized as an alternative model throughout the denomination and fulfills the provisions of ¶243 of the 2016 Book of Discipline for the United Methodist Church; and

WHEREAS, the Church Council of Cross in the Desert United Methodist Church prayerfully voted on February 28, 2023 to explore the simplified, accountable structure for local church governance; and

WHEREAS, the congregation provided feedback concerning a potential change in governance structure during three separate feedback sessions in May 2023; and

WHEREAS, the congregation was motivated to convert for reasons of efficiency, alignment with our mission, and vision, accountability, and missional focus; and

WHEREAS, the Church Council and the pastor, after months of discernment, have crafted an alternative organizational structure for Cross in the Desert United Methodist Church and offered this proposal to the district superintendent for approval; and (continued on pg. 4)

Join Us for "It's A Wonderful Life" at Don Bluth Front Row Theatre



WHEREAS, the district superintendent approved the alternative organizational plan on (date to be determined) and NOW, THEREFORE, BE IT RESOLVED THAT:

- On January 1, 2024, the Disciplinary authority and various responsibilities of the Church Council, Staff Parish Relations Committee (SPRC), Finance Committee, and Board of Trustees, will be combined into a single body called the Leadership Board. The existing elected leadership of all classes of all constituent committees that make up the new Leadership Board will conclude their terms of service on December 31, 2023, as the church transitions to the new organizational plan.
- The Committee on Nominations and Leadership Development of Cross in the Desert United Methodist Church is directed to submit a list of officers and members of a simplified, accountable structure known as the Leadership Board and a Committee on Nominations and Leadership Development, divided into appropriate three-year classes, as outlined in the Discipline, for election by the Charge Conference. All members of the Leadership Board and the Charge Conference will be professing members. The Chair of the Board of Trustees will be elected from among the voting Trustee members of the Leadership Board in the first board meeting of each year in accordance with the Discipline, and s/he may be the Leadership Board Chair.
- On January 1, 2024, the Charge Conference of Cross in the Desert United Methodist Church, will be composed of the members of the Leadership Board, appointed clergy (ex-officio), together with retired ordained ministers and retired diaconal ministers who elect to hold their memberships in our charge conference, Lay Members of Annual Conference, the Lay Leader, Treasurer and Finance Secretary (if non-staff), and the elected membership of the Committee on Nominations and Leadership Development.
- The Lay Member to Annual Conference and Lay Leader may be ex officio members of the Leadership Board, if not already elected into a membership class of the Leadership Board.
- All Disciplinary requirements and qualifications for each of the constituent committees (Church Council, SPRC, and Board of Trustees) will continue with the combined Leadership Board, including Trustee age of majority qualifications and SPRC household membership limitations.
- All references to the Church Council, Board of Trustees, SPRC, and Finance Committee, in all existing church policies, as of December 31, 2023, shall be understood to refer to the Leadership Board beginning January 1, 2024.
- The Board of Trustees is directed immediately to make appropriate amendments to the congregation's bylaws to reflect the new plan for organization and submit an update to the Secretary of State's office in a manner defined by state law for nonprofit corporations.
- In service to our common mission to make disciples of Jesus Christ for the transformation of the world, all existing ministry teams will be accountable to the Pastor and Leadership Board in administrative matters and in fulfillment of ¶243.
- The Leadership Board will abide with existing financial, child protection, building use, and personnel policies along with the inaugural Guiding Principles. The board will create a Leadership Board Covenant. The Leadership Board is empowered to amend these policies, principles, and covenant. The Leadership Board shall share updated Guiding Principles with the charge conference annually.

SIMPLIFIED, ACCOUNTABLE STRUCTURE



1. What is the Simplified, Accountable Structure?

Simplified, Accountable Structure (SAS), is a model used by many United Methodist Churches around the country to streamline their organizational structure to be more accountable, efficient, and effective than the current model.

2. Is SAS the same as a "One Board Model"?

Sort of. SAS is a model developed to support the implementation of a single board that emphasizes <u>accountability</u> by the entire church to focus on the church mission to: "Make Disciples of Jesus Christ for the Transformation of the World".

3. Does adopting SAS mean all the committees of the church go away?

No. Only the Church Council, Board of Trustees, Staff Parish Relations, and Finance committees combine into a single Leadership Board.

4. How do all the other committees such as Missions, Prayer Team, or Worship function?

This model allows for more agility for committees, teams, and task forces to do their work without the "red tape" and bureaucracy of the current structure. These teams are accountable to the pastor and the congregation for completing their work consistent with the mission and vision of CITD. Only if a team is wanting to plan a large congregation or community event and/or would like to spend substantial money from the general fund would they need to work with the Leadership Board.

5. Won't this model concentrate a lot of power into the hands of a few people?

The Leadership Board will consist of 9-12 individual leaders of the church. Staff and family members of staff or each other cannot serve on the board. Currently, the four committees that would combine to form the Leadership Board have many vacancies and do not have more than a total of 12 non-redundant members. So, right now the same decisions that will be made by the Leadership Board are being made by as few as 3 to 4 people on some individual committees.

6. How will the Leadership Board Function?

The Board should meet monthly for the primary purpose of assessing progress toward the goals identified in the annual Strategic Plan. The Board should not be spending their time hearing reports or making minor decisions. The Board should empower staff members and task forces to research, plan and implement projects, events, and programs. The Board and congregation

should stay informed on the progress of these activities through regular written communication. Task forces and/or staff that are facing challenges with achieving their identified goals will be held accountable through support and problem-solving from the board so that the church continues to move forward toward it's identified goals.

7. How will I know what the Leadership Board is doing?

Just like Church Council meetings, Leadership Board meetings will be open meetings, except when they must go into executive session to address SPRC issues (SPRC committee meetings have always been closed meetings.) It is incredibly important for the Leadership Board to establish a culture of open communication which will be included in the Guiding Principles that the board will be creating as one of their first tasks.

8. Will I still have the opportunity to get involved?

YES!!! As a matter of fact, EVERYONE must get involved to make this successful. The Leadership Board will be looking for individuals to help bring plans into reality through short-term task forces or ongoing, focused work teams. (e.g. capital campaign; community event planning; facility maintenance; children's ministry; community outreach; communications/IT support; etc. etc. etc.)

9. So what's the bottom line?

The vision is that a church that pivots to this model frees members from the endless meetings and hoops that are necessary to receive approval to complete a project that are inherent in a committee-heavy structure. More individuals can spend their time focused on serving the community and the church in ways that are meaningful to them. More time can be spent serving our brothers and sisters, fulfilling the Great Commission to spread the good word of Jesus Christ to our community and the world!

Desert Southwest Conference News

Dear Beloved Members of The United Methodist Church in the West,

Grace and peace to you in the name of Jesus Christ.

Today, a <u>jurisdictional trial concluded</u> that involved our colleague, Bishop Minerva Carcaño, as respondent. Under the oversight of presiding officer Bishop Alfred Gwinn, the trial resulted in a dismissal of all four charges against Bishop Carcaño as the jury found her actions to be within the bounds of her episcopal authority.

Although the judicial process is complete, we recognize that pain and anguish are present in this moment. We especially extend our care to those who gave voice to their convictions with courage through the complaint process and the trial. We don't minimize the hurt we all carry, and at the same time, we begin the work of healing. No verdict – innocent or guilty – will do the hard work of restoring and building the necessary trust for healthy relationships. This will require diligence, mercy, reconciliation, and restoration by all parties.

With the trial now over, the Western Jurisdiction's College of Bishops will welcome Bishop Carcaño back into our shared collaborative work. As we build new and restore old relationships, we will walk alongside her as fellow servant leaders, even as we continue to hold each other accountable in love.

We are thankful for all who contributed their time and gifts to this trial, ensuring a fair hearing of the facts and the faithful deliberations of the jury. The court's officers, presiding officer Bishop Gwinn and secretary Rev. R. Preston Price, capably facilitated while coordinating details for the relocated trial with leadership in the North Central Jurisdiction and our building host, Wespath. We also give thanks for the leaders within the Western Jurisdiction who navigated this complaint process with diligence and care, balancing the requirements of *The Discipline* with a desire to do no harm. In particular, we offer our gratitude to Rev. Janet Forbes and Richard Marsh, who dutifully represented the Church as counsel in this trial.

As your College of Bishops, we remain committed to guiding our jurisdiction through this season with integrity, compassion, and a listening spirit. We invite you to join us in prayer, seeking God's wisdom and grace as we navigate the path ahead.
