### **Service Introduction**

We provide services for overseas registered physiotherapist journey from application to registration, including written and clinical assessment pathway.

Overseas qualified physiotherapist who wants to work as a physiotherapist in Australia, will need to pass certain criteria to meet the standards of physiotherapy practice here in Australia.

The Australian Physiotherapy Council is the assessing authority for overseas qualified physiotherapists wanting to practice in Australia. The Council's role is to assess the qualifications and skills of overseas qualified physiotherapists for registration and migration purposes.

Once the Council has assessed that you meet the Australian physiotherapy competency standards, and you have received your Final Certificate, you will need to **obtain your General Registration from the** AHPRA (Board of Physiotherapy Australia)

The average **physiotherapist** salary in **Australia** is **\$93,702** per year or **\$48.05** per hour. Entry-level positions start at **\$80,001** per year, while most experienced workers make up to **\$113,613** per year.

#### Pre-requisites

- 1. Completed Bachelor in Physiotherapy or Higher
- 2. Must be registered under The Indian Association of Physiotherapists (IAP)
- 3. Male or Female Can Apply
- 4. English Proficiency Required (During Final AHPRA License Registration)

  English Proficiency is not required for Package I

#### \* English

- IELTS Overall score of at least 7 with a minimum score of 7 in each band
- PTE Overall score of at least 65 with a minimum score of 65 in each of the 4 parts.
- OET Minimum B in each Section

Remark: The score can be combined in 2 sitting within 6 months.

- 3.3 Police Clearance (Will be advised when required)

You must be prepared to provide a police certificate from each country you have lived in for 12 months or more during the past 10 years after you turned 16 years of age. Don't arrange for police certificates until we ask you to.


Remarks:

- 2.All documents must be scanned in colour.




#### Process Flow Chart - Package 1
