

**ORDINANCE CHANGING THE CITY OF LOG CABIN,  
TEXAS, TO A TYPE A GENERAL LAW MUNICIPALITY**

WHEREAS, the City of Log Cabin, Texas (the "City") has been duly incorporated and is validly existing and operating as a Type B general law municipality under the Constitution and laws of the State of Texas;

WHEREAS, the governing body of the City (the "City Council") is authorized by Section 6.011, Texas Local Government Code, as amended, to change the status of the City to a Type A general law municipality if the City Council determines that the City meets the requirements set forth in said Section 6.011;

WHEREAS, this City Council hereby finds and determines that the City has 600 or more inhabitants;

WHEREAS, this City Council hereby finds and determines that it is in the best interests of and will be a benefit to the City and its inhabitants for the City to change to a Type A general law municipality; and

WHEREAS, the meeting at which this Ordinance is considered is a regular meeting of the City Council, is open to the public as required by law, and the public notice of the time, place and purpose of said meeting was given as required by Tex. Gov't Code Ann. ch. 551, as amended; Now, Therefore

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOG CABIN, TEXAS:**

Section 1. The statements contained in the preamble of this Ordinance are true and correct and are adopted as findings of fact and operative provisions hereof.

Section 2. The City is hereby changed to a Type A general law municipality and shall have all powers of, and shall operate under the laws applicable to, a Type A general law municipality under the Constitution and laws of the State of Texas.

Section 3. This Ordinance shall be signed by the Mayor and attested by the City Secretary under the corporate seal of the City, and this Ordinance and the vote of this City Council hereon shall be recorded in the journal of the proceedings of the City Council.

Section 4. A certified copy of this Ordinance shall be filed and recorded in the office of the County Clerk of Henderson County.

Section 6. This Ordinance shall be effective immediately upon its passage.

Passed and approved by a vote of 5 "For" and 0 "Against" and effective this 20th Day Nov, 1997

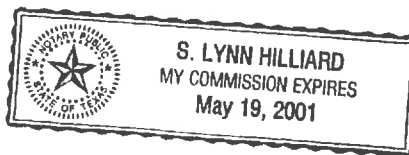
