**E-bicycle safety – Enhance your local e-bike safety efforts - seminar is scheduled for Thursday, May 15 at 12 noon.**

The e-bike safety seminar will provide you with information about local e-bike safety and education programs, and state resources on e-bike safety courses provided for children, parents, and all ages of e-bike riders – You will learn how and why the e-bike safety program was set up, how it is funded or other resources involved, who it is intended for, and how to tap into the program to enhance your efforts to advance e-bike safety in the communities you serve.

**Swim lesson access drowning prevention water safety seminar is scheduled for Thursday, June 5 at 12 noon.** The swim lesson drowning prevention seminar will provide you with program examples and concepts to consider for increasing swim lesson access for children of all ages, and parent water safety knowledge education, including working with children with special needs. How and why the program was set up, how it is funded or other resources involved, who it is intended for, and how to tap into the program information to enhance your efforts to advance drowning prevention, increasing swim skills and water competency and parent water safety education in the communities you serve.

Upcoming Safer California injury prevention seminar topics will cover issues such as traffic safety (teen driver safety, bicycle and pedestrian safety, child passenger safety, etc.), drowning prevention and water safety, baby/infant sleep suffocation prevention, poisoning prevention, sports safety (primarily concussion, heat stroke, and cardiac arrest safety), young child window falls prevention, burns prevention, advancing Kaitlin's law prohibiting leaving young children in parked vehicles, prevention working with children with special needs (water safety, child passenger safety, safe sleep), Kids Plates funding reforms supporting child abuse and childhood injury prevention, and childcare safety, and how to tap into the Safer California Injury Prevention Action Plan Report.
