For the Enroller – By signing this Pre-Launch Independent Social Entrepreneur (“ISE”) Application and Agreement, as the Enroller of the above-listed Applicant, I agree to fulfill the obligations as his or her Enroller as described or shall be described in the Global Prosperity Solutions Policies and Procedures.

1. Pre-Launch Applicant (“Applicant”) understands that Global Prosperity Solutions, LLC (“Global Prosperity Solutions” or the “Company”) is preparing to launch a network marketing program to market functional foods, but that Global Prosperity Solutions has not yet completed the design and programming of its compensation plan, nor has it completed the Terms and Conditions of its ISE Agreement or the Policies and Procedures that will govern the relationship between Global Prosperity Solutions and its ISEs. The sole and exclusive purpose of the pre-launch phase is to allow persons interested in becoming Global Prosperity Solutions ISEs to develop Customers and to begin enrolling other prospective ISEs for their Global Prosperity Solutions downline once the Global Prosperity Solutions program is officially launched. Applicant understands that during this pre-launch phase, no products or services will be purchased or available for sale from Global Prosperity Solutions, no commissions, bonuses, overrides, or any other form of compensation will be paid. Applicant further agrees that under no circumstances will he/she shall collect any monies, credit card numbers, or any other form of remuneration from any prospective Customer or other ISE Applicant.

4. Applicant may begin taking Global Prosperity Solutions Customer Applications and Agreements from prospective Customers and pre-launch ISE Applications and Agreements from prospective Global Prosperity Solutions ISEs in order to build his/her prospective Global Prosperity Solutions business. Global Prosperity Solutions shall use its best efforts to secure the downline structure desired by Applicant based upon the Pre-Launch Applications and Agreements submitted by ISEs. However, Applicant understands and agrees that because Global Prosperity Solutions’ compensation plan is not fully developed, and the software programming is not yet complete, Global Prosperity Solutions cannot guarantee that Applicant’s downline genealogy will appear exactly as Applicant desires or intends. **Applicant waives any and all claims against Global Prosperity Solutions, its officers, directors, owners, employees and agents for any loss or damage arising from or relating to downline ISE placements within the structure of Applicant’s Global Prosperity Solutions downline organization.**
