**Inspiration:** Consider incorporating elements of the "cyber woman" concept, such as a strong, confident female figure, neutral nationality, symbols of technology and innovation, and the IWCD brand colours that evoke power, intelligence, and creativity.

#### **Guidelines**

- **Design Submissions:** Submit your design as a high-resolution digital file (JPEG, PNG, or PDF) to <a href="mailto:official@womenincyberday.org">official@womenincyberday.org</a> by August 28, 2024. Please <a href="mailto:include">include</a> your name, city, country, phone number, and a brief description of how you developed your design concept, explaining how it aligns with <a href="mailto:International Womenin Cyber Day">International Womenin Cyber Day</a> and the contest theme.
- **Ownership:** By submitting your design, you confirm that you are the sole author and owner of the intellectual property rights. The winner will grant the **Women**<u>CyberSecurity Society</u> full intellectual property rights¹ to the winning design.
- **Judging Criteria:** Designs will be evaluated based on creativity, originality, relevance to the theme, and overall impact. A panel of industry experts and representatives from WCS2 will select the winner.
- **Prize:** The grand prize winner will receive a cash award of \$500 CAD, along with the esteemed recognition of having their design represent International Women in Cyber Day. The winning logo and designer will be featured on our website and social media platforms.

- **Size:** 500 x 500 pixels.
- **Image:** Transparent background.
- **Brand Colours:** Primary brand colours must be incorporated into the design (#ffd230,#1bcbd6, #451e5d).
- File Formats: .png, .jpg, .gif, .svg, along with original document creation.
- AI Usage: AI tools may be used to assist in the design process, however, we encourage a blend of human creativity and technological innovation. We expect that a portion of the logo design should be original, human-generated artwork.
- WCS2 Logo: The WCS2 logo must be incorporated into the new IWCD Logo. Visit our website to download the WCS2 logo.
- Up to three submissions per person.
