## BREEDER and BUYER agree to the following:

- 1. Purchase Price. The full purchase price is \$\_\_\_\_\_ ("Purchase Price"). .
- 2. Limited Registration. The puppy described above is registerable with the AKC. The puppy is being transferred with limited registration, which does not allow show or breeding rights for the puppy. BREEDER agrees to provide the BUYER with all appropriate registration papers.
- 3. Breeder Obligations. BREEDER represents and warrants the following:
  - a. <u>Ownership</u>. Judith Arline Haggard Martinez is the lawful owner of the puppy and has the right to transfer ownership. Ownership of the puppy will be transferred at the time of completed delivery
  - b. <u>State of Health</u>; BREEDER represents that the puppy has been examined by a licensed veterinarian and was found to be in good health at that time and has had the immunizations and parasite control enumerated in the health record provided.
  - c. <u>2 Year Genetic Warranty</u>: Puppy is free from genetic defect to the best of BREEDER's knowledge. If puppy develops a congenital, inherited or DNA related illnes within the first two years, upon BREEDER's veternarian verification of said illness, puppy will be, at BUYER's discretion, either replaced with a comparable puppy (return of the afflicted puppy is required) or an amount (up to the original purchase price of the puppy), will be refunded to help cover cost of treatment (copy of expenses required). Any further expenses, over the original purchase price of the puppy, will be the BUYER's responsibility.
  - d. <u>No Other Warranties</u>: No other warranties or guarantees, expressed or implied, are made by the BREEDER except as expressly and specifically set forth herein. Control of Parasites, Guiardia, Coccidia, vaccinations are the responsibility of BUYER.
- 4. BUYER Obligations. BUYER agrees to the following:
  - a. <u>Proper Care</u>. BUYER will provide good and proper care of the puppy. Such care includes providing adequate housing and protection from the elements, a safe exercise area, and proper and sufficient nutrition. Puppy will be provided routine vaccinations for common infectious diseases; routine treatment for internal and external parasites; and annual examination by a licensed veterinarian.
  - b. <u>Spay or Neutering</u>: Puppy is sold with Limited Registration which prohibits breeding. Puppy is required to be spayed or neutered (as applicable) before they are TWO years old.
  - c. <u>Sale Prohibition</u>. Neither party is acting as an agent in the purchase of the puppy. BUYER agrees

neither the puppy, nor any offspring of the puppy, shall be sold by or through any commercial broker or wholesale establishment, any chain store, catalog sales house or pet store. If, at any time, the BUYER is unable or unwilling to care for the puppy, the BREEDER will be contacted and given right of first refusal, unless prior arrngements are approved in advance.

- d. <u>Buyer Satisfaction</u>. Personality and physical traits anticipated by the BREEDER are based on parent's traits and personal experience. Each puppy is an individual and will develop as such. Corgis coats do change in color and texture, as they grow. Personalities can change due to exposures in the puppy's environment and training. BREEDER cannot guarantee that the puppy will develop into the dog their BUYER desires.
- 5. Ongoing Communications. BUYER agrees to (a) maintain contact with BREEDER regarding the puppy/dog at least once each calendar year, and to reply as promptly as possible to inquiries about the puppy from BREEDER; (b) Inform BREEDER of any major change in the health of the puppy throughout the puppy's life. BUYER will, upon the natural or accidental death of the puppy/dog, promptly notify BREEDER of the particulars of the animal's passing.
- 6. **Social Media & Agreement to Mediate.** If a dispute arises out of or relates to this Agreement, or the alleged breach thereof, and if the dispute is not settled through negotiation, the parties agree first to try in good faith to settle the dispute by mediation before resorting to arbitration, litigation, or some other dispute resolution procedure. Neither party will defame the other in any way. All discussions will be private and confidential.
- 7. **Governing Law.** This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by and construed in accordance with the laws of the State of Louisiana without regard to the conflicts of laws provisions thereof.
- 8. **Miscellaneous.** This Agreement constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all prior or contemporaneous agreements, negotiations, discussions and understandings, written or oral, between the parties with respect to such subject matter. Neither party may assign, transfer, or subcontract any obligations (or rights) under this Agreement without the prior written consent of the other party. No changes, modifications or waivers to this Agreement will be effective unless in writing and signed by both parties. In the event that any provision of this Agreement is determined to be illegal or unenforceable, that provision will be limited or eliminated to the minimum extent necessary so that this Agreement shall otherwise remain in full force and effect and enforceable. This Agreement may be executed in any number of counterparts and such counterparts together shall constitute the same instrument. This Agreement may be executed by electronic signature, which shall be considered as an original signature for all purposes and shall have the same force and effect as an original signature.
