Did you know??

As of October 1, 2024, home owners in Florida are required to 1) disclose if they have submitted a flood claim AND 2) disclose if they have received Federal funds related to that claim when selling their property. For buyers, a key point will be to request documentation of any repairs made- to include replacing appliances that were a part of a claim. Otherwise, future damage claims could be denied for the new home owners.

Key Steps:

- Document everything! Photos and video of all damaged property and personal items. Do this throughout the steps below.
- Contact your insurance company and file claims. Follow up frequently as needed.
- Contact FEMA to apply for additional assistance.
- Take steps to mitigate loss and further damage including removing effected items
