While the defendant's COMPAS Assessment Score might justify acceptance, his residence excludes him, as he is currently living in Phoenix, Arizona. As a result, the undersigned will not be able to provide close supervision to ensure compliance.

Therefore, it is recommended the defendant not be accepted into the Riverside County Veterans Court, unless he is able to establish and provide proof of residency in Riverside County.
