TUITION REBATE PROGRAM ENROLLMENT FORM

The HNS Tuition Rebate Program gives school families the opportunity to earn a tuition credit on December 1st and May 1st of each school year by purchasing gift cards from the Holy Name Tuition Rebate Office. Holy Name School purchases the gift cards at a discounted price from local and national merchants (see Tuition Rebate Order Form for list of merchants). Our families buy the gift cards at their face value. The difference between the gift cards' face

1. After an initial \$150 per family Contribution, Tuition rebates are allocated 50% to the school family and 50% to Holy Name School.
2. All orders must be paid in full at time of purchase. Make checks payable to Holy Name Tuition Rebate.
3. A \$20 fee will be charged for returned checks due to nonsufficient funds (NSF) and \$30 for ScripNOW (NSF).
4. Tuition Rebate certificates are the same as cash and should be handled accordingly. Holy Name is not responsible for certificates that are lost, stolen or misplaced while in your possession.
5. Tuition Rebate certificates and gift cards nonreturnable.
6. Tuition Rebate certificates are NOT tax deductible because you receive dollar for dollar value.
7. In consideration of other Tuition Rebate customers and in order to keep our inventory costs to a minimum, if you are planning a Tuition Rebate purchase in excess of \$500 from one merchant, you must place your order a week in advance.
8. Families must sign a Waiver of Responsibility (see below) before certificates will be released to your student for

delivery.

9. Families should verify the accuracy of the Tuition Rebate order delivered by their student immediately upon receipt. In the unlikely event of a discrepancy, please contact the Holy Name Tuition Rebate Office as soon as possible.

10. Purchasing families are responsible for knowing the "usage guidelines" for the retailers from whom they purchase Tuition Rebates.

11. The maximum tuition credit you can receive in a school year is the amount of your family's tuition.

12. Tuition Credits revert to Holy Name School in the event that the students do not attend Holy Name School.
