PRE-LICENSE AGREEMENT

Crescent City Driving School, LLC. (herein after referred to as the "school"), agrees to give qualified, licensed instructions for the purpose of obtaining a Louisiana Class E Driver's License.

The school does not guarantee the securing of a Louisiana Class E Driver's License to operate a motor vehicle. The test will consist of 40 or more questions including signs, lane markings and signals. A score of 80% or better is required to pass. Each student shall be allowed to take the test twice the first day. If the student fails the test both times, he may retest twice the next day thereafter until he passes. Upon completion of the test the student shall deliver the sealed envelope to the GMV. Any test that is not in a sealed envelope when presented to the OMV shall be rejected and the student will be instructed to return to the driving school to retake the knowledge test. Any student caught cheating will forfeit his test and will not be allowed to retest for thirty days. The OMV has the right to retest you on both the knowledge and skills test.

DEPOSITS: there will be a \$100 non-refundable fee if for any reason a student decides to not attend class or drops out of the school. \$50 fee if a student does not show up on the day of class and has to be moved to another class. \$25 fee if a student does not show up for BTW lesson.
