Parade Rules:

1. The parade will assemble at 5:00pm Saturday July 13th at the Dollar General then move north toward the Bridge.
2. Final Deadline for submitting applications is Friday July 11, 2019 by 5 pm.
3. Participants must keep their assigned places throughout the route.
4. No candies, favors, pamphlets or other objects will be distributed along the parade route.
5. No one is allowed to ride in vehicles with the tailgate open, and all persons riding on the float must remain on the float until the parade ends. Children must remain seated throughout the route.
6. Please maintain any music at a reasonable level so as not to drown out another entry
7. Please no performances that stop the flow of traffic.
8. Float design must ensure that the driver has clear vision ahead and to the sides and that they are safe, with no sharp edges or protruding rails.
9. Minimum distance between entrants will be 50 feet.
10. All drivers must be licensed to drive the vehicles they are operating.

NOTE: REFUSAL TO FOLLOW SAFETY DIRECTIONS WILL RESULT IN THE IMMEDIATE EXPULSION OF THE OFFENDING ENTRY FROM THE PARADE.

Vendor Rules:

1. There is a \$10.00 non-refundable fee.
2. Set-up will start at 3:00 p.m.
3. Please limit your space to one booth per group or organization.
4. Vendors must provide their own booth/Generators if needed.
5. Certain food vendors must obtain food permits from Cameron County Public Health. Please contact them at 1390 West Expressway 83 San Benito, Texas 78586 or call (956) 247-3685 for more information.
6. No music is allowed in booths.

NOTE: PLEASE DISPLAY YOUR FOOD PERMITS AT YOUR BOOTH. IF PERMITS ARE REQUIRED & NOT OBTAINED, VENDOR WILL BE ASKED TO LEAVE.
