- **4. Meet & Greet:** Each ARBC board member gave a brief description of their professional/personal backgrounds. The board is made up of 7 parish presidents or their designee, and 6 governor-appointed professionals with engineering and/or other related backgrounds.
- **5.** CPRA Overview of ARBC by Lawrence Marino as follows:
 - ARBC formation in 1981
 - A description of the Amite River Basin hydrologically and legally
 - ARBC Authority before and after Act 490
 - ARBC duties
 - Exercise that management and control of watershed management
 - Prioritize reduction of flood risk and flood insurance premiums
 - Develop annual plans for watershed management
 - Develop a master plan for watershed management including projects, programs, planning, permitting, development, and waterway management. Similar to the CPRA Master Plan. Identify objectives, include structural, nonstructural, management, and institutional components. Identify project and programs to do, costs, and justification. Subject to approval of House and Senate Transportation Committees.
 - Promulgate regulations for watershed management in the district, including regarding a comprehensive list of specified topics. List good insight into what ARBC's management and control responsibility requires. Subject to approval of House and Senate Transportation Committees. Due 1/1/26.
 - Develop and implement a plan to manage and maintain all waterways in the district regarding watershed management.
 - Report annually to parish presidents and parish governing authorities, legislature, and committee of legislators whose districts include any part of the Amite River Basin.
 - Cooperate with parishes regarding their risk mitigation plans to ensure they consider impacts of drainage, flood control, and water resource management. Identify how to participate in FEMA's Community Rating System.

ARBC Powers

• Sue and be sued, buy and sell property, make contracts, construct and maintain drainage works of all types, alone or in cooperation with other political subdivisions, enter land to do surveys, expropriate needed property rights, adopt bylaws, control watershed management.

- Other Resources Available to ARBC include DOTD, CPRA, PLD (reimbursement required), contractors. For service contracts, the only requirements are self-imposed.
- \$8M to CPRA in Act 170, p.2 for "Implementation Program for the ARBC for the ARB Flood Risk Reduction Study". Not for regular operations, but for annual plan, master plan, regulations. CEA needed.
- Authority to levy taxes and issue bonds.
- Conflict Issues

ARBC commissioners will receive training in the Code of Governmental Ethics. Discussed conflicts, specifically what agencies the privately employed Commissioners (or their companies) can work for.
