03/22/23 08:47 I arrived at _____ and made contact with pet owner Katie. She stated that her boyfriend admitted to hitting her dog and has caused the dog injuries. I asked to see the dog, "Pancho" and she brought him down. Pancho was DAR and when placed on the ground to walk he was stiff. His tail was wagging a little and when he went to walk he yelped out in pain. I offered her w/s to fill out, she stated that she would like to wait to press charges as the boyfriend is still on the lease and she wants him removed. She stated that if we move forward he may not sign to be removed. I offered that we impound the dog for 10 days to get him examined and to give her time to handle her lease. She declined at this time, I left her w/s and asked if he will be returning to the home. She stated that he moved out and no longer has a key. As I was typing notes, her boyfriend called and asked to speak with me.

I spoke with Daniel Hall DOB 08/15/200 over the phone and he stated that he hit his girlfriends dog, he does not know why and he is trying to get help. He stated that he does not want us to take the dog from her and he does not want to get in trouble. I asked him why he hit Pancho and he stated he did not know why, he just did it out of no where. He stated that it only happend two times and he has never hurt a dog before. I let him know we will contact him if we need any more information.

I called 24 hour emergency center on Tropicana and requested vet records from Panchos visits. I provided them with the email to send the records. Closing call pending w/s and vet records CE187
