
1 After reviewing the information, Officer Riley gathered the evidence and sent an Animal Cruelty

3 cruelty charges on behalf of NRS 574.053

4 On November 6th, 2023, CCAPS Dispatch received a call from NRS 574.053 advising
5 that LVMPD Detectives had informed N they were not filing charges. I reviewed the witness statements
6 and prepared this request for prosecution.

7 **Based on the information contained herein, this officer has cause to believe and does**
8 **believe that the subject named herein was/is in violation of county ordinances and/or**
9 **NRS statutes as described and prays for the issuance of a summons or warrant.**
