#### STREET PARKING

We all from time to time may have to park a vehicle on the street for a short period of time. If you have a business that involves trucks, trailers or any other type of equipment that is parked on the streets on a regular basis, FIND SOME WHERE ELSE TO PARK THEM. You can rent storage space from the office or move them onto your property before we have them towed. If you do not, you are putting all of your neighbors in danger by limiting thru traffic like a fire truck or ambulance. Please be respectful to the rest of the property owners in Holiday Villages.

#### **NEW RANGER TRUCK**

You may not have noticed since the truck that was purchased to replace the oil burner that the Rangers were driving is also white. The truck purchased is a 2006 Ford F150 with 69,000 miles on it. The cost for this truck was \$9,995. The old truck was sold (as is) for \$1,250.

#### **HVLOA ROAD IMPROVEMENT**

## Why are the roads in such bad condition and not repaired more than they are?

Holiday Villages of Livingston is over twenty years old and there were no major repairs or investment from the original developer (Tecon Corporation). The Holiday Villages of Livingston Owners Association (HVLOA) took over control of the Village from Tecon in 2015 (date to be confirmed). HVLOA members voted against a special road assessment twice after taking over control from Tecon. A Road Assessment was passed on a third attempt for the year 2018. When the Road Assessment was passed, the HVLOA dedicated a special account for the Road Fund.

All our cross streets, like St. Thomas, are approximately 1,500 feet long. The average cost to dig ditches, have road base put down, and complete the chip and seal process for one cross street is \$45,000 to \$50,000. When the average revenue collected each year for the roads is approximately \$150,000, we can complete three streets a year. Meanwhile, patching of holes is a full-time job. And to make matters worse, heavy rains destroy any repairs to ongoing patching. Since our maintenance guys have other responsibilities, there are many days that work on the roads is not done.

#### DRAINAGE DITCHES

## Why is cleaning out ditches considered part of new road construction instead of regular maintenance?

Due to the cost of digging the ditches, they fall under road repairs instead of general maintenance. Materials like cold patch purchased to patch potholes fall under regular road maintenance. It is the property owner's responsibility to keep their culverts cleaned out and weeds trimmed on both ends of their culverts.

### **ROAD CONSTRUCTION**

While we are awaiting the arrival of Waters Construction, our contractor for the road maintenance and improvement, we have initiated a program to drop road base material at the larger problem areas and spread immediately, if possible, by Danny and Kevin, our maintenance staff. We recently relieved 27 different locations in that manner, mak-

ing many problem areas more manageable until we can get them addressed more permanently. The base used in these areas is not wasted as it will be ground up and reused in the final repair process. We expect Waters Construction to arrive in August to begin the next phase of street repairs.



#### NON-LICENSED VEHICLES

Golf Carts and Side-By-Sides must have a driver at least 14 years old or a parent or guardian must be in the vehicle with them at all times; NO EXCEPTIONS. Over the past July 4<sup>th</sup> weekend there were so many underage drivers on our streets it was alarming. Some kids think it is a joke when they are speeding and not paying attention behind the wheel. This continues to be a growing problem that is bringing a lot of attention to all of us. There are parents that allow their child under 14 to either drive in front of them or behind them on a mini-bike or small ATV. THIS IS NOT ALLOWED.

We are open for suggestions on how to handle this problem. One of the solutions being considered is to hire two additional sheriffs during busy holiday weekends to specifically monitor underage drivers while they patrol our streets. We are also considering charging parents a hefty fine if they allow their underage child to operate a vehicle within Holiday Villages of Livingston. Changes will be made to address this problem. We are asking all our community members to bring ideas to the Town Hall meeting August 21<sup>st</sup> at 9am. It may be necessary to register all our golf carts and off-road vehicles at the office and put a HVL sticker on them, so we know what vehicles belong in the village and which do not. There are other ideas that will be discussed at the Town Hall meeting in August. Please attend

#### **HVLOA MAILBOXES**

#### Why can't I rent a mailbox?

We have added sixty new mailboxes in the last eighteen months. However, due to the increase of new residents, mailboxes at the front gate are only being offered to residents that live in Holiday Villages of Livingston full time. Until you become a full-time resident in the Village, you can rent a PO Box at the Onalaska post office.

#### **SWIMMING POOL**

Further discussions have taken place with regards to accessing the pool area. We believe we have a good plan to move forward but are waiting on final details. This system will allow us to increase security and limit access to HVLOA members who are not current on their dues and anyone not following pool rules. We are currently having problems with people violating the NO GLASS BOTTLES rule.

When using the pool, please do not move or adjust the sprinkler head. The sprinkler head is necessary to help cool the pool water during these hot temperatures. The pool is monitored with cameras at all times.

#### **BLESSINGS BOXES**

Heidi and Troy Campbell, property owners in Holiday Villages have set up two Blessings Boxes. One is located outside our Clubhouse Office, and one is inside the Clubhouse. The concept is helping people that need help while creating KINDNESS...WHAT A CONCEPT! Thank you, Heidi and Troy, for you kindness and generosity.

The blessings boxes contain only non-perishable food items & toiletries. "Take what you need, leave/give what you can" is the slogan. If you need an item or two, please take them. If you can leave an item, please do so. Some-

#### **BOAT RAMP IMPROVEMENTS**

Another noticeable improvement for our events this year was adding parking space near the boat ramp. A new location was made for the bands that play at our events. These improvements should allow events to continue more efficiently and with less burden on private property owners around event locations.

Gates have been installed at both the entrance and exit ramps. The gates are intended to stay open and only close, when necessary, like during the fireworks display this past July 3<sup>rd</sup>. To clarify the rumors regarding the gates... the gates were closed to stop vehicle traffic, not to stop foot traffic. The pyrotechnics folks establish the setback where we all must stay behind during the fireworks display. Anyone can set up chairs behind the taped off and in the area behind the closed gates during the firework show. The vehicles that were allowed behind the gates on July 3<sup>rd</sup> were either members of the fireworks crew or the band members, not residents.

These changes and other improvements will provide a safer environment, which is the #1 concern when having events.

#### SURVEY RESULTS ON TRASH PICKUP

The HVLOA Board members are continually looking for ways to help preserve our roads. One suggestion is to limit Holiday Villages of Livingston (HVLOA) is a Deed Rethe number of heavy trash trucks that access our roads on a weekly basis. Changing to one trash company will reduce the number of trash trucks using our roads. The results of a survey conducted by HVLOA are as follows:

Question 1. What trash company do you currently use in Holiday Villages?

(Usually take it home when they leave.)

Question 2. Do you think it would be a good idea to only have one trash service company in Holiday Villages?

> 92 residents Yes: 57 residents No: Undecided: 2 residents Other: 2 residents

Thanks to all who contributed to the survey. This information is helpful and will be considered if this issue is put on the ballot in May of 2022.

#### **DEED RESTRICTED COMMUNITY**

stricted Community. Deed restrictions exist to maintain standards so that everyone may enjoy the community. If you are not familiar with the community deed restrictions, please visit the HVLOA website to read the restrictions.

The deed restrictions include keeping your grass cut on a regular basis. No appliances should be seen outdoors. If you have one in your yard, please move it. If you have a broken-down car, truck, boat, ATV or other vehicle with a motor on your property that does not run, have it towed away. If your yard has trash and junk piled up in it, you need to clean it up and have it removed. If not, you will receive a violation.

#### ENTERING HOLIDAY VILLAGES FRONT GATE

Remind your guests and contractors that if they pull up to the Ranger Station and the Ranger is away from the office, they must backup and park off to the side to allow other property owners access to Holiday Villages. Do not tailgate. The average cost to repair a damaged gate is \$1,000. If you damage the gate, you will be responsible for the cost to repair the gate plus the cost to repair your vehicle.

#### RANGERS ADDED TO WORK BUSY WEEKENDS

We are now scheduling two Rangers per shift on busy weekends to prevent the gate from backing up when one Ranger is called away to the back gate or Section J.
