He has investigated labor and trafficking cases culminating in the successful conviction of multiple traffickers in the U.S. Federal Court. He is a subject matter expert in human trafficking and has been selected to present on human trafficking to foreign officials in Colombia, Argentina, Mexico, Panama, and El Salvador. At the Savannah HSI, SA Miranda continues to promote efforts to combat human trafficking and has initiated multiple human trafficking investigations in Georgia.

Having served two tours in the U.S. Army from March, 1997 to March, 2004, SA Miranda is a combat veteran. He earned a Bachelor's Degree in Multi-Disciplinary Studies from University of Texas at El Paso (UTEP) and has also earned a certificate in Intelligence and Homeland Security from UTEP.

Victor Boutros

Victor Boutros is the CEO and Founding Director of the Human Trafficking Institute.

Mr. Boutros previously served as a federal prosecutor, investigating and trying international human trafficking cases on behalf of the United States Department of Justice's Human Trafficking Prosecution Unit. He has taught human trafficking at the FBI Academy in Quantico, trained law enforcement professionals in the United States and other countries to investigate and prosecute human trafficking, and has taught trial advocacy to lawyers from Latin America, South and Southeast Asia, and Africa. Prior to his work with the Justice Department, Mr. Boutros spent time on similar issues in the developing world.

Mr. Boutros is a graduate of Baylor University, Harvard University, Oxford University, and the University of Chicago Law School. He has written broadly on foreign affairs and human rights, as well as developed and taught a course on human rights, human trafficking, and rule of law in the developing world. He speaks to corporate leaders, universities, think tanks, and senior government leaders on human trafficking.

Mr. Boutros co-authored *The Locust Effect: Why the End of Poverty Requires the End of Violence* (2014) with Gary Haugen. *The Locust Effect* paints a vivid portrait of the way fractured criminal justice systems in developing countries have spawned a hidden epidemic of modern-day slavery and everyday violence. Messrs. Boutros and Haugen received the Grawemeyer Prize for Ideas Improving World Order in 2016 for the book's originality, feasibility, and potential for global impact.

Greg Gilluly

Greg Gilluly is an Assistant United States Attorney in the Southern District of Georgia. Mr. Gilluly serves as the Deputy Criminal Chief, and formerly served as the Organized Crime Drug Enforcement Task Force (OCDETF) Chief.

Mr. Gilluly is a federal prosecutor who primarily handles complex organized crime cases. He has practiced law for a couple of decades, and for the majority of his career, he has served as a federal prosecutor. He has dismantled violent criminal enterprises involved in international drug trafficking, international human trafficking and international money laundering.

Mr. Gilluly has received multiple OCDETF National Awards, a US DOJ Director's Award, and national awards from ATF, FBI, Homeland Security Investigations, and various Offices of Inspector General. Mr. Gilluly has given presentations throughout the United States human trafficking and organized crime.

Tania Groover is an Assistant United States Attorney and the point of contact for all human trafficking cases in the Southern District of Georgia. She is the coordinator for the Federal Human Trafficking Task Force in the Southern District of Georgia.

Ms. Groover has over 18 years' experience as a state and federal prosecutor working victim cases involving sex trafficking, labor trafficking, child exploitation, rape and sexual assault, domestic violence, elder abuse, and homicide. In addition to prosecuting cases, She works with law enforcement, victim-witness service providers, government agencies, and non-governmental organizations to help identify victims and provide victim services in human trafficking cases.
