I am transferring temporary possession for a board period of Dog to Dayna Padgett hereafter referred to as Kennel, under the following terms and conditions, and no other expressed or implied:						
[] Owner is supplying all food and supplies. [] Owner is not supplying all food and supplies, and Owner will pay an additional fee per day for use of the following food or supplies: (<i>specify</i>)						
Boarding Fee: [] \$20.00 per day. Dog was sold by Kennel. Owner is providing all food and supplies. [] \$30.00 per day. Dog was not sold by Kennel but is a housemate of Dog sold by Kennel. and Kennel will provide the rest.
[] \$40.00 per day. Dog was not sold by Kennel but is a housemate of Dog sold by
Kennel. Owner is providing all food OR all supplies and Kennel will provide the rest.
[] \$40.00 per day. Dog was sold by Kennel. Owner is not providing any food or supplies,
and Kennel will provide both.
[] \$50.00 per day. Dog was not sold by Kennel but is a housemate of dog sold by Kennel.
Owner is not providing any food or supplies, and Kennel will provide both.
[] Free board for military deployment, natural disaster required evacuation, or state of
emergency declared. Dog was bred by Kennel. Kennel will supply anything Owners
cannot.
[] Half price board for military deployment, natural disaster required evacuation, or state
of emergency declared. Dog was not sold by Kennel but is a housemate of dog sold by
Kennel. Kennel will supply anything Owners cannot.
[] Board period is less than 14 days, there will be no license needed.
[] Board Period is 14 days or longer. Kennel must obtain a license for Dog. Dog is
neutered and license fee is \$10.00. This is added to boarding fees.
[] Board Period is 14 days or longer. Kennel must obtain a license for Dog. Dog is intact,
and license fee is \$75.00. This is added to boarding fees.

Specialized training that may impact Dog's behaviors (I.e. bite or other protection training, detection, competition, etc.):

Boarding period begins on (*dd month*, *20yy*) and will end on (*dd month*, *20yy*). Kennel requires payment in full at drop off. Dog may be dropped off between 8:00 AM and 1:00 PM on drop off date, and must be picked up between 8:00 AM and 1:00 PM on pick up date. If pick up date must change and Dog is picked up sooner, Kennel will reimburse Owner unused days. If Dog cannot be picked up on the pick up date, Owner will pay additional days at pick up, along with a fee of \$10.00 per day per dog for a late fee. If Dog is picked up after 1:00 PM, Kennel will charge another full day board fee plus late fee.

If Dog is not picked up on the pick up date, Owner must contact Kennel every day with updates as to the new pick up date. If Owner does not contact Kennel for a period of 3 days after original pick up date, Kennel will assume Dog has been abandoned and will take legal and registry action to claim full ownership of Dog.

If delayed pick up is a result of travel problems due to weather or bona fide emergency, Owner and Kennel will void this contract, and activate a new contract with the new pickup date to eliminate the additional late fees.

If delayed pick up is a result of travel problems due to state of emergency or natural disaster, Owner and Kennel will void this contract and activate a new contract with an open ended pick up date to eliminate late fees. Dog must be picked up within 5 days after SOE lifted.

In the event that pickup date changes, and this causes a shortage of food or supplies that Owner provided, Kennel will begin to provides food or supplies, and add the difference in cost to late fees and other fees at pickup.

Kennel is not responsible for any supplies brought and left with Dog. This includes collar, lead, training collar, bed, etc. Kennel suggests that such items are clearly marked with Owner's last name, Dog name, Dog's microchip number, or other identifying system.

If housemate being boarded does not currently have an ISO compliant microchip or does not have a microchip that can be located and read with Kennel's scanner, Owner must purchase such microchip and have it inserted prior to dropoff. Kennel does not require microchip be registered, but it must be ISO compliant and readable with Kennel's scanner.

If Owner does not provide all food and supplies for Dog, Kennel will charge additional per day. Kennel will use whatever supplies and food brands that Kennel uses on Kennel's dogs. Kennel will not purchase special food, supplements, or supplies for Dog.

Owner must submit ORIGINAL current rabies certificate with Dog's microchip numbers written or microchip number sticker applied. Certificate will be returned when Dog is picked up. If Dog is being boarded for longer than 14 days, Kennel must purchase a license for Dog, and this expense will be added to boarding fees. Owner will be allowed to keep license tag for Dog. If Dog is altered (full castration, full hysterectomy, or alternate neutering, such as Zeuter, OSS, or Vasectomy) Owner must submit paperwork to Kennel showing Dog is not intact for reduced cost license. If Owner does not submit such paperwork, intact dog license fee will be charged. Spay/neuter status marked on rabies certificate is sufficient for proof for reduced license fee.

Owner understands that Dog will not leave Kennel property at any time during the board period. Dog will be exercised on premises and will not be walked or taken to dog parks during the board period. Dog will not be trained or worked by Kennel during board period. Dog will not be allowed contact with Kennel's dogs, or any other dogs on the property except housemates being boarded at the same time.

Owner understands that Dog will not wear a collar or harness at any time for safety purposes. Dog will only have his collar on when on lead.

Owner understands that Dog will be kept in the quarantine area. Dog will be given a yard in this section. If Dog is not used to being isolated, and gets very upset, anxious, aggressive, or fearful, or exhibits undesirable behaviors, Dog will be crated at night, and only put in the yard during the day. Under no circumstances, will Dog be kept in the house, or in the actual kennel facility.

Kennel is not responsible for any aggressive action or behavior exhibited by Dog. Kennel will exercise reasonable care and control over Dog, but Kennel cannot be held liable for

behavior or temperament issues that Kennel is not made aware of. Kennel will do everything possible to protect Dog from illness, injury, or death at the hands of other animals, people, or Dog's own actions. Kennel is only responsible for illness, injury, or death if it can be proven that Kennel was negligent in the care and control over Dog.

If Dog gets lost, runs away, or otherwise goes missing during the board period, Kennel will contact Owner immediately. Kennel will make a reasonable effort to locate Dog, including visiting all rescues, animal shelters, veterinarians, and police stations in the area. Kennel will personally visit all facilities daily to locate Dog. Owner will be required to notify microchip registry, and report Dog lost through this method. Kennel will also post flyers in the general area.

Owner agrees that Owner has fully disclosed any and all training, behavior, or temperament issues. If Owner does not disclose such issues, Owner will be legally and financially responsible for any and all legal repercussions due to Dog's behavior and actions.

Owner agrees that Owner has fully disclosed any and all health problems, illnesses, injuries, etc. If Owner does not disclose such issues, Owner will be legally and financially responsible for medical care resulting from gaps in necessary treatment.

If Dog requires emergency treatment for a life threatening or life limiting injury or illness, Kennel reserves the right to obtain necessary life saving and life stabilizing treatment at Kennel's veterinarian even prior to notification to Owner. Kennel will make a reasonable attempt to notify Owner, but will not delay emergency life saving treatment if necessary.

If Dog needs medical treatment for a less serious issue, Kennel will notify Owner before treatment. All treatment will be carried out by Kennel's veterinarian.

Owner is responsible for all routine and emergency veterinary expenses incurred during the board period, unless it is proven that Kennel was negligent in the care and control of Dog. Should Dog need veterinary care, Kennel will give Owner veterinarian contact information, so Owner can directly contact veterinarian and make payment arrangements.

Owner is responsible for getting all records pertaining to all necessary care from Kennel's veterinarian to give to Owner's veterinarian.

If Dog will be due for heartworm prevention during the board period, Owner is required to provide this treatment. Kennel will supply all other parasite control if needed during the board period. If Owner does not supply needed heartworm treatment, Owner will have to pay Kennel's veterinarian for heartworm test as well as the heartworm medication.

If intact or OSS female is boarded during heat cycle, or comes into heat during the board period, Owner agrees that Kennel will segregate Dog from all dogs, including

We understand that if any dispute arises out of this contract, such dispute will be handled and resolved only between Owner and Kennel and legal representatives hired by parties. We understand that neither party will take the dispute to social media or any internet forum or discuss the dispute with any other party during resolution time. After resolution, the dispute may be posted on social media and internet forums or discussed freely, but only with evidence-based facts. Any unproven allegations posted on social media or internet forums, or discussed in person, will be considered libel or slander, and the posting/discussing party will be legally and financially responsible for any damages resulting from such posting/discussion.

All disputes will be handled by mediation in Kennel's county at Owner's expense. If mediation does not resolve such dispute, we agree that litigation will be handled by civil court in Kennel's county at Owner's expense.

We, the undersigned, testify that we have read, understand, and agree to all terms and conditions expressed herein.
