**RESOLUTION 2026-12**

**A RESOLUTION AWARDING A STATE CONTRACT FOR  
SCBA AIR PACK PURCHASE**

**WHEREAS**, N.J.S.A. 40A:11-12 provides that a contracting unit may, without advertising for bids, purchase any materials, supplies or equipment under any contract entered into on behalf of the State by the Division of Purchase and Property in the Department of Treasury and Local Cooperative Contract Purchasing Systems; and,

**WHEREAS**, the District has authorized purchases under the appropriate State Contract and Cooperative Contract Purchasing Systems, and utilized the bidding advantage done by the State and Cooperatives; and,

**WHEREAS**, it is desirable from time-to-time to obtain materials, supplies and equipment under contracts for such materials, supplies and equipment entered into on behalf of the State by the said Division and Local Cooperative Contract Purchasing Systems without the necessity of advertising for bids, or in the cases where no bids have been received; and,

**WHEREAS**, the District desires to engage MES Service Company LLC, in the purchase of 21 3M Scott AirPak X3 Pro Self-Contained Breathing Apparatus and Accessories under State Contract 25-COMG-131390 entered on behalf of the State of New Jersey by said Division and Local Cooperative Contract Purchasing Systems during the year 2026;

**NOW THEREFORE, BE IT RESOLVED** by the Commissioners of Fire District No. 2 in the Township of Moorestown, County of Burlington as follows:

- (1) The purchases by Moorestown Fire District No. 2 shall be purchased under a contract or contracts for Self-Contained Breathing Apparatus entered into on behalf of the State of New Jersey by the Division of Purchase and Property in the Department

of the Treasury and Local Cooperative Contract Purchasing Systems as MES Service Company LLC under State Contract/Master Blanket Purchase Order Number 25-COMG-131390, under contract T0790 in the amount of \$232,414.77 where it is desirable and in the best interest of Moorestown Township Fire District No. 2.

- (2) This resolution shall become effective immediately upon final adoption.


