*RESOLUTION AUTHORIZING THE SALE OF SURPLUS PERSONAL  
PROPERTY NO LONGER NEEDED FOR PUBLIC USE ON AN ONLINE  
AUCTION WEBSITE*

WHEREAS, The Board of Fire Commissioners of Fire District No. 2, Township of Moorestown, County of Burlington, State of New Jersey has determined that the property described on Schedule A attached hereto and incorporated herein is no longer needed for public use; and

WHEREAS, the Local Unit Electronic Technology Pilot Program and Study Act (P.L. 2001, c. 30) authorizes the sale of surplus personal property no longer needed for public use through the use of an online auction service; and

WHEREAS, the Board of Fire Commissioners, Fire District No. 2 intends to utilize the online auction services of GovDeals, Inc., located at [www.govdeals.com](http://www.govdeals.com) pursuant to New Jersey State Contract A-83453/T-2581, and

WHEREAS, the On-Line auction shall be conducted pursuant to the provisions of N.J.S.A. 40A:11-36 and New Jersey Local Finance Notice 2008-9; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 2, Township of Moorestown, County of Burlington, State of New Jersey, as follows:

1. That the Board is hereby authorized to sell the surplus personal property as indicated on Schedule A on an online auction to the highest bidder through New Jersey State Contract vendor GovDeals, Inc. in accordance with New Jersey State Contract A-83453/T-2581 and New Jersey Local Finance Notice 2008-9.
2. That the surplus property shall be sold in an "as-is" condition without express or implied warranties.
3. That the Board reserves the right to reject any and all bids if it determines such rejection to be in the best interest of the Fire District.

4. That the Notice to Bidders with the date, time and internet address of the auction, will be published in the official newspaper pursuant to N.J.S.A 40A:11-36 and New Jersey Local Finance Notice 2008-9, if applicable.


