**RESOLUTION 2026-03
RESOLUTION TO AMEND THE 2026 BUDGET PURSUANT TO
N.J.S.A 40A:14-78.3
FISCAL YEAR: FROM JANUARY 1, 2026 TO DECEMBER 31, 2026**

WHEREAS the Fire District Budget for the Fiscal Year beginning on January 1, 2026 and ending on December 31, 2026 was introduced on the 10th day of December, 2025; and

WHEREAS, a public hearing was held on December 10th as publicly advertised; and

WHEREAS, the Board desires to amend certain line items in the 2026 Budget; and

NOW THEREFORE, BE IT RESOLVED by the Commissioners of Fire District No. 2 in the Township of Moorestown, County of Burlington that the following amendments to the introduced 2026 Budget be made:

Budgeted Appropriations

- (1) F-1 Total Admin from \$330,423 to \$343,488
- (2) F-1 Total COM from \$1,323,929 to \$1,074,364
- (3) F-1 Capital From \$50,000 to \$286,500
- (4) F-3 Other Detail 11-15, from \$71,100 to \$71,600
- (5) F-3 COM Retired Benefits from \$32,370 to \$0
- (6) F-3 COM Fringe from \$181,077 to \$213,447
- (7) F-3 COM Maintenance and Repairs from \$193,460 to \$180,195
- (8) F-3 COM FF Equipment from \$261,500 to \$25,050
- (9) F-3 Capital Appropriations from \$50,000 to 286,500
- (10) F-4 Admin Fringe from \$9,373 to \$21,938
- (11) F-5 Capital Improvements \$236,500 SCBA AirPack Replacement
- (12) F-5 Total Capital Improvement \$236,500

(13) F-5 Capital Total Capital Appropriations from \$50,000 to \$286,500


