## NOTICE TO APPLICANTS:

Any tenant wishing to install communications service must have WRITTEN permission from the unit owner since the unit owner will be liable for situations that may arise from such an installation. The HOA owns the building roof, exterior walls, patio covers, carports and exterior fence in addition to the grounds on the property. Therefore, any cable or satellite dish installation cannot be attached to any of those items owned by the Association. Cables, splitters and/or other related equipment cannot be attached to or mounted to any of these HOA elements. Satellite dishes must be 36" or less in diameter and gray or white. An exterior wiring plan must be submitted to the HOA in advance of the

installation. Only one point of entry into the building is permitted and must be shown on the exterior wiring plan. Denver fire regulations prohibit cables from being attached to the Xcel gas lines that are located at the back of every housing unit.

IT IS UNDERSTOOD BY THE APPLICANT that if this installation is deemed in violation of the Association's regulations, the Association will – at the Applicant's expense – remove the violation. All homes were wired for Dish Network and DirecTV services in 2013. Due to the geographical positioning of each building, it may not be possible to obtain or install any other satellite TV service via the owner's available exclusive use area.
