STEP UP FOR STUDENTS (DIRECT PAY):

Families using Step Up may select Ohana Farm and Gardens as a direct provider.

Funds are billed monthly after services are rendered.

- Please reserve tuition through your Step Up EMA portal based on how many days per week your child is enrolled (1 or 2).
- We will confirm the reservation on our end in EMA and send you a confirmation email once received.

IMPORTANT NOTES:

- Tuition is billed monthly and due by the first day of each month.
- Enrollment Deposit: One month's tuition is due at the time of enrollment to hold your child's spot. This deposit will be applied to your final month's tuition if proper notice is given.
- If you choose to pause enrollment, you are welcome to re-enroll at any point during the year, as long as

- Flexible Enrollment: We do not require a year-long commitment. We offer monthly enrollment to support the natural rhythm of homeschooling. Please provide 30 days' notice if you do not wish to re-enroll.
- Drop-in payments are due on the day of attendance, space permitting.
- No refunds or makeup days will be provided for missed classes.
