Any time a 401(k) transaction falls outside of your stated thresholds, we'll notify you.

We monitor your banking activity and alert you when a checking or savings account application is submitted in your name, or when changes are made to your personal information.

#### **Compromised Credentials**

We deploy bots and human intelligence operatives to scour closed hacker forums for your email address, driver's license and other ID cards, credit card numbers, or Social Security number information and notify you at once with anything we've found.

#### Web Login Scan

If your username is detected on the dark web, we'll send you an alert.

#### Credit/Debit Card Scan

We'll alert you if we find that one of your credit or debit card numbers is mentioned, used, or listed for sale on the dark web.

#### Synthetic Identity Fraud Coverage

We monitor for synthetic identity theft, which is a type of fraud that involves a criminal taking your real information and combining it with fake information to create a new identity.
