BoD Meetings

Past & Pending

Meetings of the Deer Creek Board of Directors are governed by Article III of the Bylaws and a 2014 policy on Procedures for Conducting Meetings (all available at HOA website). The Bylaws require the BoD meet at least once annually, but it has become customary to meet quarterly. Homeowners must be notified 15 to 30 days in advance of any meeting and have the right to speak during the first 15 minutes. It is recommended that owners wishing to speak notify the Board in advance of the meeting (email contacts listed at left). Owners are limited because the HOA can be charged overtime for meetings that run over, though Diversified Management has been very accommodating.

The 2024 Board of Directors first met on November 12th, 2023. The meeting focused on the usual review of finances and discussion of events for 2024. The official minutes will be posted on the HOA website after they are approved at the next BoD meeting.

According to Sharon Wood, the focus of the next BoD meeting will be discussion of proposed snow removal and landscape contracts for 2024, and the beginning of plans for the community picnic, the garage sale, and plans for the south common area. She invites any community members to attend the beginning of the meeting to address any ideas or concerns they may want to share. As indicated on the 2024 HOA Calendar below, the next HOA meeting will convene 6:30 pm on February 13th, at 2102 Silver Creek Dr.

Tips to Keep Pipes from Freezing

In the midst of an Arctic Vortex, or just plain Colorado winter, here are some expert tips to help keep your pipes from freezing.

Outdoors

- Turn off water at the shut-off valve for each outdoor spigot.
- Disconnect hoses from outdoor spigots.
- Wrap exposed pipes in hose bibb covers.
- Where possible, consider wrapping pipes with heat tape.

Indoors (when extremely cold outside or household heating fails)

- Open doors under sinks in the bathroom and kitchen.
- Close doors to rooms without fixtures to direct heat to pipes.
- Run some water to keep it moving through pipes.

Colorado Primary Elections

Colorado will conduct two primary elections in 2024. On March 5th, both the Republican and Democrat parties will hold primaries for the position of President of the United States. On June 25th, both parties will again hold primaries to select candidates for respective positions in the US House of Representatives and Colorado House, Senate, and Board of Education.

For the Presidential Primary, the Colorado Secretary of State will mail ballots to eligible voters by February 12th. Eligible voters must be at least 18 years of age, lived in-state 22 days before the election, and not serving a sentence for a felony conviction. Voters affiliated with the Republican or Democrat party will receive one ballot for their party only. Unaffiliated voters will receive two ballots, one for each party, but may return only one. Ballots must be returned by March 5th, 2024.

On December 19th, 2023, the Colorado Supreme Court ruled that former President Donald Trump was ineligible to run for election in Colorado. On December 28th, the Colorado Republican Party appealed the decision to the US Supreme Court. On January 6th 2024 the Supreme Court accepted the case and is expected to make a ruling by February 8th.
