## **Recycling Update**

### **Republic Issuing Conflicting Guidance**

Last September we announced Republic Services would remove the \$60 surcharge they added to Deer Creek residents who pay for recycling. In January they issued bills for \$169.28 with the surcharge still added. On January 14th, a Republic agent affirmed the correct amount was \$101.76 and said a refund would be individually issued. Since then, the HOA has been working with Republic to get the refund extended to all Deer Creek residents who recycle. Hopefully we will have an answer soon.

### Scam Alert!

Phone scams continue to grow in number and sophistication. The con artists try to put you into a position where you feel the need to take immediate action. Don't do it. Hang up. Call somebody you trust. Here are some common phone scams to watch for:

- You won the lottery, but you must pay to claim your prize.
- Police need you to pay bail for a family member they jailed.
- A hospital needs money before it can operate on a family member.
- The IRS says it will seize your property if you don't pay back taxes.
- Utilities will cut your service if you don't pay past bills.
- A distressed grandchild asks you to help with financial problems.

## **BoD Members Register in FINCEN**

In 2021 the President signed into law the Corporate Transparency Act (CTA). The law is meant to combat financial crimes such as money laundering, terrorist financing, and tax evasion. The law went into effect January 1st, 2024. It requires most corporations, LLCs, and other financial entities to register with the Financial Crimes Enforcement Network (FinCEN) with the US Treasury Department. HOA Board Members were required to register with FinCEN by January 1st, 2025.

## **Don't Forget Valentine's Day!**

Valentine's day traces its origins to ancient Rome and the Feast of Lupercalia celebrating Juno, the Goddess of Women and Marriage. The festival was later associated with the legend of Valentinus, a Roman priest who married young couples in defiance of Emperor Claudius who suspended marriage in order to recruit soldiers for his legions. In 498 AD, Pope Gelasius formally recognized February 14th in honor of Saint Valentine. Today, Valentine's Day is celebrated across most of Europe and the Americas. Among the many customs is the exchange of love notes called 'Valentines'. The tradition is said to have begun in 1415 when Charles, the Duke of Orleans, sent the first known Valentine to his wife from prison. More cards are exchanged on Valentine's Day than any other holiday except Christmas. Chocolates and flowers are also popularly exchanged on this date. Regardless of its origins, a day celebrating love and romance helps warm our hearts in mid-winter, and reminds us of the coming bloom of spring.
