#### **IV. Booster Reports:**

**a. President CaraMia Begay–**

e. Parent Representative Samantha Rivera –

- Families will be able to order MHS Football T-shirts soon. We will have an order form at upcoming 7on7 and other events.
- August 6 Corn Hole Tournament. \$50.00 pre registration \$60.00 day of. Asking players to bring at least 2 teams. Double elimination. Please bring Easy ups and Chairs.

Comments: Parent brought up the idea of having the Corn Hole tournament at the Saw Mill next year.

- We are asking Players to donate water and Gatorade for upcoming events.
- Coach has asked to have Sports physicals done by July 10.
