






GASS is the nation's biggest philatelic event, hosted by the three largest philatelic organizations in the United States – the American Philatelic Society, the American Topical Association, and the American First Day Cover Society. The show is sponsored by the United States Postal Service, who will host a large retail area as well as multiple first day ceremonies. GASS will feature 80+ dealers selling stamps, covers, and other philatelic material; hundreds of frames of stamp exhibits and rarities; participation of 40+ national specialty societies; a youth area; and meetings and seminars.

7. Ferrophilliac Philately –
Collectors of locomotives,
etc., are known as
Ferrophilliacs. Collectors
of postage stamps depicting
railroads are called
Ferrophilliac Philatelists.




8. Flat Plate - Stamps printed in sheets from flat-bed presses as distinguished from rotary, where the plates are curved around a cylinder and the stamps printed on "endless" roles of paper. When both flat and rotary plates are made for the same stamp, they are transferred from the same



original die, but the curving of the rotary plate afterward causes the design to lengthen slightly around the circumference, thus making the rotary printing longer in one direction than the flat plate printing.

9. **Franking Privilege** – A right employed by the Government officials of sending letters and packages free by mail. It was first granted by Congress, January 1776, to private soldiers in service, and was gradually extended. The privilege was abolished by Congress, January 31, 1873, but certain features were later restored and are still in existence. By special Accts of Congress, the privilege has been granted to widows of


- 10. **Philately as a Science** The science of stamp collecting sometimes expressed in collecting "varieties" demonstrates that stamp collecting is not merely a passing hobby of persons whose accumulating instincts need an outlet. Simply put, stamp collecting is rather a recreation and a pleasure with occasional profit which is increased by observation and study. **Be a Student of the Science of Philately**. *Editor* –
- 11. **Garter Stamps** Refers to Wells, Fargo stamp. \$1.00 blue. This stamp was one of the Wels, Fargo Pony Express issues, its use intended apparently, on mail from the East to the West according to evidence gleaned from used copies on and off cover. The Counterfeit of this issue is instantly identified by the



addition of a horizontal line measuring 61/2 mm which divides the 1/2 oz. and \$1.00.

12. **Gregory's California Express** – Was established in 1850, operating from California. Marks as: Gregory's New York &

California Express; Gregory's Atlantic and Pacific Express; Gregor's Nevada Express. Listed Stamp Specialist No. 2. Story, V.M. Berthold Coll. Club Philatelist, 1932.



13. **Gum Breaker Bars** – Colorless marks across the backs of some rotary press stamps placed there during manufacture to prevent the stamps from curling.

#### **Definitions**

The following definition of EFO and other terms are here in support of the ongoing Editors Corner series on Varieties, EFO's and Counterfeits.

**EFO** is the shorthand for "Error, Freak, or Oddity". It's a term applied to philatelic items that were formed unintentionally abnormal.

Errors: Are usually "major" errors having catalog status where something in the process has gone entirely wrong. **Examples of "errors" are** <u>consistent</u>, unintentional deviations from the normal. Typically errors are stamps that are wrongly perforated, both between or completely imperforated, Full incorrect, shifted or omitted color(s), inverted centers or frames, multiple impressions, missing/inverted surcharges, missing or wrong watermarks or tagging and FULL stamps on either side of an interpane gutter, factually wrong or misspelled information etc.

Freaks: Also called "varieties", are generally defined as a lesser degree of production problem. Typically freaks have flaws that are not consistent or do not have catalog status.

## A Very Successful San Diego Stamp Show

February 23-25, 2024

Once again, the Poway Stamp Club participated in the 4<sup>th</sup> successful San Diego Stamp Show. Our members were available on Thursday to assist with installing the exhibits. Many club members met at the Mission Valley Hilton and helped to install the 200+ frames with world class exhibits. Thanks to **Art Berg, Bill Wacenske, Bill Range, Thor Strom, Rich Stern, Dave and Trice Klauber as well as Bernard Vertelov** for the help.

The show opened to a crowd on Friday morning. Volunteers during the show included, David Waller, Larry and Doris Parlin, Valerie Merritt, Darby Walker, Bill Wacenske, Olivia Inthavong, Sharon Nagaran, Neil Lyles, Nick Soroka, Dean Jordan, Lili Sorman, Bonnie Dunnells, Brian Morgan, Bill Gallagher, David Klauber, Trice Klauber and Art Berg. Members manned both the show booth as well as worked as greeters at the entrance to the exhibit hall. We had 63 members who picked up vouchers and occupied the bourse seats throughout the show, filling those want lists and making the show a booming success.

Examples of freaks include ink smudges, off center perforation shifts, partially missing colors or partial/random color shifts, preprinting paper folds, paper creases, over or under inked stamps, and so forth. Freaks often sell for less than their "error" counterparts. Printing plate cracks, wear and other flaws such as repairs or re-entries are freaks and not typically considered to be errors.

#### **Oddities:**

The catch-all category for anything that is left. Oddities can be subtle problems that do not have catalog status. Examples can be cancel and plate varieties, inverted USPS cancels, very minor perforation shifts, minor color shifts, etc. Most oddities are a curiosity and have lower EFO values.

There continues to be a debate about the definition of freaks vs oddities. This is one area where a classification can be a matter of personal opinion. Frequently the debate is over pre-printing paper folds and centers on how minor (oddity) or how major (freak) a fold is. As it turns out, one mans freak, is a another mans oddity.

Counterfeit, Forgery, or Fake.

Counterfeit: Fraudulent reproduction of a stamp meant to defraud the issuing authority. (Typically used as postage)

Forgery: Fraudulent reproduction or alteration of a stamp meant to defraud (not the issuing authority), In philately, forged stamps are altered to defraud the buyer.

Fakes: An imitation stamp, or reprint. There are many fakes on the market, typically sold as fakes they are rarely sold as genuine. In philately, fakes are an expression of art are not offered as genuine to defraud. (reprints may be considered fakes)

The Show Bourse was complete with over 20 Vendors and Major Societies, including the **San Diego Philatelic Library**. Several club and/or library members helped to support the library table including **Neil Schneider**, **Art Berg**, **Bill O'Connor**, **Bill Gallagher**, **Steve Twenge**, **David Klauber**, **Trice Klauber**. This was the library's first appearance at the show, and we wish them every success in the future. Also present at the show were the **U.S. Philatelic Classics Society**, **The Collectors Club**, **The India Study Circle**, and the **US Postal Service** each offering show attendees the opportunity to learn and grow in our hobby.

Friday the 23rd: There were several learning opportunities including a discussion of Illustrated Transcontinental Directional Envelopes by David D'Alessandris (USPCS), a session on the Postal history of the Revolutionary War by Vern Morris (USPCS), and a presentation by Charles Epting (Siegel) on Buying & Selling at Auctions and the future of the BidBaller auction platform and Siegel Auctions. Charles discussed several software access advantages that are available in BidBaller including the ability to participate in live auctions, access account histories, utilize features such as view, sort, filter and save searches of auction lots based on a wide range of criteria.

**Saturday the 24**<sup>th</sup>: The US Postal Service provided special San Diego Show and Date cancellations for the Basketball Coach, **John Wooden** stamp and FDC taking place in Los Angeles on Saturday 2/24. Many members took advantage of the opportunity to have their programs and FDC covers cancelled for this event.

# More Important Definitions

#### Reissues

(A reprint of a currently available stamp)

#### **Reprints**

(Copies of the obsolete originals, or previously issued.
They are sold by the Government they are not classified as proofs and sometimes printed for collector's purposes only

#### **Special Printings**

(Original plate stamps for nonpostal use, while originals are still valid for postage)

# Government issued Reproductions

(Not printed from the original plates, not valid postage, considered likenesses.)

Examples US Scott 3-4

#### **Se-tenant Pair**

A planned pair, strip or block of adjacent stamps (either horizontal or vertical), which were printed from the same plate and/or sheet. The stamps must be un-separated and deliberately different from each other by design, color, denomination or overprint.

#### **Type-Variety/Combination**

Pair – An unplanned pair, strip or block of adjacent stamps (either horizontal or vertical).

The stamps must be unsevered and are different from each other by variety, meaning that at least one member of the pair/strip/block differs in some detail from the "normal" issue. The detail may or may not be an actual philatelic "error".




## Member Article

# **Philatelic Book Report**

I have just finished reading a book named, *A History of Britain in Thirty-Six Postage Stamps* by Chris West, Picador, New York, 2013, Fist Edition.

Each stamp presented focuses on a particular era or event that the author then places in an historical context. The first stamp seems

an obvious choice, that being
Great Britain Scott number 1,
normally referred to as the
Penny Black. A history of the
development of the first postage
stamp in relation to the great
improvements in technical
innovation, transportation,
simplified pre-paid pricing and
advances in literacy are explored
in the context of this simple, but
very complex process of
ultimately world-wide communication.



The eight's stamp presented is not British but from one of the colonies, Hong Kong, Scott 11, a 5-cent blue image of Victoria. Why Hong Kong you may ask? Hong Kong became the British gateway to China, and after the Opium Wars, the British were able to export vast quantities of opium, thus avoid an enormous disparity in export/import products. Tea was a major import for the United Kingdom, and very



few products produced by the British were needed by the Chinese. One good thing from the Chinese perspective was that China was able to limit the property that encompassed Hong Kong and after 97 years, Hong Kong was returned to China. Some may question how well the citizens of Hong Kong have fared during this transition?

The 12<sup>th</sup> stamp is also not British; it is a German overprinted stamp, Scott 269, 2 million marks on a 200-mark stamp of 1923. The reason this stamp is used is to indicate the world-wide problems of hyperinflation that affected the entire world, but most specifically Germany. Chris West places the blame on the Germany use of borrowed money to fund the war, World War 1, while many others would blame the Treaty of



Versailles and the huge reparations forced upon Germany to pay for the entire cost of the war. History mores on and a second-rate artist and a first-rate propagandist, Adolph Hitler becomes leader of Germany, and the world is still dealing with ramifications of the global war that followed.

The other 33 stamps presented are all British. Many references to the kings, queens, and of course Princess Diana permeate the book. Sports, music, technology, politics, wars, Europe, AIDS, David Beckham, Rachel Carson, DNA, IRA, and even Mary Robinson. One cautionary tale the author ponders at the end is whether Britain is looking more inward than looking to the future. That might be a concern for all of us.


I think many of you will enjoy reading the book, particularly if you encompass our past. The book does have a section that gives specifics as to the stamp, its value, technical aspects to its development, and numbers produced. The more modern stamps seem to have very little economic value and the author stops indicating value. As for any hobby, it is always the enjoyment one gets from collecting and understanding of the items collected.

I mentioned only Mary Robinson as I had the privilege of meeting her at a reception at the University of California, Riverside, far too many years ago. She by the way was the President of Ireland, and the first person from Northern Ireland to be selected President of Ireland.

# **Every Cover Tells a Story**

I found this cover on eBay in one of my Saved Seller stores. It was described as "US Cover Carried by Richard Bruce on World Flight". I felt that there were several things wrong with this description. First, it wasn't a US cover because it bears a British stamp with a February 27, 1931, cancel. Second, the name on the cover didn't look like Richard Bruce but more like Milford or Mildred Bruce. I searched for Richard or Milford Bruce as around the world pilots, but none existed. Then I found a website that listed a 1930 around the world flight by a Mrs. Victor Bruce. I found Mrs. Victor Bruce to be Mrs. Mildred Mary Petre Bruce and what a story ensued.


Mildred Mary Petre was born in November 1895 in Essex, England. Her father was a British nobleman, and she grew up in a life of luxury. Mildred liked a life of adventure. At 15, she took her brother's motorcycle and was stopped for speeding, given a citation, fined, and told not to ride a motorcycle until she was 16. In 1926, she married the Honorable Victor Austin Bruce who was a son of the 2nd Baron Aberdare.

Victor Bruce had been an auto racer and hill climbing champion in his AC Company cars. The two of them formed a perfect team. The Bruce's became well known auto racers, hill climbers, and endurance drivers in the late 1920's. In 1927, the Bruce's drove 250 miles north of the Arctic Circle. At the time, this was the farthest north an automobile had ever been driven. Mildred finished 6th (the first woman to finish) in the 1927 Monte Carlo Rally. In 1929, she purchased a motorboat and set a round trip speed record for a trip across the English Channel.

As you can see Mildred was a risk taker. Now let's tell the story behind this cover. Having conquered land and water, she turned her attentions to the air. She obtained her pilots license in July of 1930. In the same month, she purchased a Blackburn Bluebird. The biplane airplane had an open cockpit and had to be modified for her around the world trip. On September 25th, 1930, equipped with an extra fuel tank, maps, 44 hours of flying experience, and her husband's compass, Mildred took off from the Heston Aerodrome in Croydon, England. She flew southeast across Europe to Turkey, then to Iraq, India, Burma, Thailand, Vietnam (Indochina), China, and Korea. On November 24th, 1930, she landed in Tokyo. There, she loaded her airplane on a boat and sailed for Vancouver, Canada. Once in Canada, her airplane was reassembled, and her flight continued down the west coast of the United States to San Diego. From San Diego, the route took her to Chicago then east to New York City arriving in February of 1931. Again, her airplane was dis-assembled and placed on ship bound for Le Havre, France. Once her airplane was put back together, she flew from France back to England on February 19th. The next day, her around the world journey ended when she landed back in Croydon, England. It had taken her 148 days and 19,000 miles to go around the world. The around the world flight was not without incident. An oil leak caused her to land on the shore of the Persian Gulf. A monsoon forced an emergency landing along the Mekong River in Vietnam where she caught malaria. Crashes in Oregon and Maryland delayed her flight. Finally, Mildred was arrested in New York City for flying circles around the Empire State Building.

The flight did set three records: the first person to fly from China to Korea across the Yellow Sea, the first England to Japan flight, and the first around the world flight by a woman. This cover was posted one week after her return.

One thing you can say about Mildred Mary Petre Bruce is that she lived life in the fast lane. She remained active in aviation attempting and setting many flight endurance records. By founding her own airline company in 1934, she became Britain's first female airline entrepreneur. As an author, she wrote two books. The first entitled The Bluebird Flight published in 1931 about her around the world flight and her autobiography called Nine Lives Plus in 1977. Mildred died on May 21st, 1990, in Camden Town, London at the age of 94.

# You Can't Take Them with You



In my previous articles, I gave some insight into my investigations regarding the best way to divest myself of my collections. There are many options. My first article "Dad left me what?" discussed gifting my collection to a museum or dispersing them to family and friends. My second article "The Collector's Catch-22" focused on donating portions of my collection to obtain the tax benefits while I'm still alive and in my third article "Uh Oh, Now What?" I discussed my idea of teaching my family about my collections so that they can more easily dispense with them when I'm gone. In this, my final article on this subject, I discuss what may be a perfect solution to this dilemma, gifting my collection to a stamp club.



No, No, No! You cannot take your stamps with you.

If you are like me and none of your family is interested in collecting stamps or keeping your stamp collection, what do you do? Well, the old saying, "You can't take them with you!" is a reality we all must face at some time in our lives (Figure 1). Considering all of my research, I recommend two options if you are not able to sell your collections before you leave this world: 1) devise the entire collection to a stamp club specifically designated as a non-profit organization in your will or trust and obtain a tax write-off against your estate or 2) devise the collection to your family with the intent to have them donate the stamps to a stamp club allowing them to take a write off on the value of these donations.

When considering **option 1**, it is important to know that the rules regarding charitable contributions are different for individuals than for estates and trusts(https://farr.com/deducting-a-trusts-charitable-donations/). For example,

- An estate or trust income tax charitable deduction is potentially unlimited, while the deduction for individuals is capped at 50 percent of an individual's adjusted gross income;
- Estates are afforded a deduction for amounts permanently set aside for charitable purposes.
   Individuals (and generally trusts) receive a deduction only for amounts actually paid to charities; and
- Estates can take deductions for donations to U.S. charities as well as to foreign charitable organizations.
   Individuals are permitted a charitable deduction only for donations to U.S. charities.

Understanding these differences is important. For example, there will be little benefit if the Executor/Executrix of your estate donates property to a charitable organization because you cannot itemize the donation on your final personal tax return, nor is it a deduction from the value of your assets for determining whether your estate owes estate taxes. However, if you state in your will or trust that you would like your collection donated to a named charity, then this will count as a deduction for the purposes of calculating any estate taxes that may be due.

**Note:** tax laws change on a regular basis so any consideration of the options provided here should be reviewed by a tax accountant before making any changes to your existing will or trust.

**Option 2** allows your family to claim a tax deduction on the value of the stamps if they donate your collection to a charitable organization (*e.g.*, a 501(c)(3) non-profit organization). Of course, it would be best to let your family know which charitable organization you would like to receive your collection as well as the estimated value of that collection prior to your departure. The value for tax deduction purposes will be the value of the stamps as determined on the date of your death or the value given the collection by the Executor/Executrix when the estate assets are submitted for probate.

Charitable or non-profit organizations will often provide a letter recognizing the donation, which allows the donor to reduce their tax burden in the year that the items are donated. However, most will not assign a value to your donation, so it will be up to you and your heirs to make these determinations. The designated value of a given donation will determine whether an appraisal will be required under the U.S. Tax Code, see my article "The Collector's Catch-22". In addition, if the collection has a substantial value, then it may be best to make multiple donations over several years to maximize the tax benefits (Figure 2). At a minimum, a comprehensive listing of the items being donated at any given time should be prepared and maintained with the letter received from the charitable organization in the event the IRS requires additional information. I recommend creating and maintaining a listing for your loved one(s) in the event your departure occurs unexpectedly. In addition, it would be best to update the listing regularly and include either the current market value or the price you paid for each stamp. Maintain an electronic version of the listing on your computer and/or a hard copy of the listing in an easily accessed location. My listing is in a clearly marked file on my computer and I keep a printout (i.e., a currently updated printout) of the file next to my desk in a three-ring binder labeled "Collections".

It is important to note that any donation that exceeds the value established by the IRS will require an appraisal from an IRS approved appraiser of stamps. The value may also be determined by an IRS registered appraiser provided in a written document that may be submitted to the IRS.


#### In general:

- 1. You must file Form 8283 to report information about noncash charitable contributions for which you are claiming a tax deduction;
- 2. You must file a Form 8283 for each noncash contribution that is more than \$500; and
- 3. You must obtain a written appraisal from a qualified appraiser (see below) for an item, or group of items, exceeding \$5,000.00.

**Note:** this is a general summary of what may be required for donations of a specified value. It is highly recommended that you contact a certified tax accountant and have them review any documents before submitting them to the IRS.

#### What is a Qualified Appraisal?

The federal tax laws require that the: 1) appraisal be prepared by a qualified appraiser in accordance with the Uniform Standards of Professional Appraisal Practice; 2) appraisal must be signed and dated by the qualified appraiser; and 3) appraiser must make a declaration on Form 8283 (Figure 3) prior to submission.

**Note:** Since the tax laws change regularly you should check with a tax accountant and have them review any documents before submitting them to the IRS.

#### Who is a Qualified Appraiser?

A qualified appraiser (Figure 4) is an individual who meets all the following criteria:

- 1. The individual either:
  - **A.** has earned a recognized appraiser designation from a recognized professional appraiser organization for demonstrated competency in valuing the type of property being appraised,
    OR
  - **B.** has met certain minimum education requirements and has two or more years of experience in valuing the type of property being appraised. To meet the minimum education requirements, the individual must have successfully completed professional or college-level coursework in valuing the type of property and the education must be from:
    - a professional or college-level educational organization,
    - ii. a recognized professional trade or appraiser organization that regularly offers educational programs, or
- an employer as part of an employee apprenticeship or education program similar to professional or college-level courses. The appraiser regularly prepares appraisals for which he/she is paid;

- The appraiser specifies his/her education and experience in appraising the type of property being valued in the appraisal; AND
- The appraiser makes a declaration in the appraisal that, because of his/her experience and education, he/she is qualified to make appraisals of the type of property being valued.

It is also important to note that: 1) a party to the transaction, one who is benefitting from the transaction for which the appraisal is being prepared, is not qualified to sign the declaration; 2) if you fail to disclose or misrepresent facts that cause the appraiser to misstate the value of the property being donated, then the appraisal will not be accepted as a "qualified appraisal"; and 3) the appraisal fees cannot be based on a percentage of the appraised value.

The remaining and most important determination is which charitable organization would be best to receive your stamp collection. Personally, I want my collection to go to an organization that supports philatelic research, promotes stamp collecting and disseminates knowledge about stamps and stamp collecting to the public. I would also like my stamps to be enjoyed by as many collectors as possible; meaning I would like them to be distributed to other collectors. Consequently, selecting an organization that meets these goals would be perfect. For me, the American Philatelic Society is one such organization.

My decision to retain my collection during my lifetime is part of my nature as a collector. The feeling that my stamps will be distributed to other collectors who will enjoy them for years to come provides me comfort in knowing they will be taken care of and cherished when I am gone. Either of the options above will allow me to satisfy this desire and obtain a financial benefit for my family either personally or through my estate.

I hope that you have enjoyed this series of articles and that the information provided is helpful in making future decisions regarding your stamp collection.
