HORSE B&B CONTRACT

This is an agreement made on this day between, SonnyDaze Ranch as hereinafter referred to as Barn/Stable/Owner(s) and who is hereinafter referred to as Customer/Private Horse Owner.

SonnyDaze Ranch will provide a B&B Barn Stay for Private Horse Owner's stated horse(s) as named in this agreement, starting on below stated check-in date and time and ending on below stated check-out date and time, for a fee as stated within this agreement. Private Horse Owner has selected a 'stay package' which describes all the included and/or excluded amenities that the stable will provide for said horse(s), along with costs. Customer/Private Horse Owner is responsible for delivery of said horse(s), unless otherwise specified in this agreement, to arrive at or after agreed upon check-in time and leave by agreed upon check-out time. Note: Customer will be charged an additional day if delivery of horse(s) is prior to check-in time or after check-out time.

Customer agrees that their horse(s) is current and up to date on all necessary shots and has provided proof of such. Customer understands that the stable has a right to refuse entry to the barn if horse(s) appear to be ill/sick/injured/emaciated/out of control/dangerous/need medical attention regularly/unable to settle in or appear unhealthy in any way. Customer also understands the obligation and right that the stable must report any suspected cases of animal abuse, including neglect to the appropriate authorities and agencies.

Customer understands the inherent risks that a horse as a wild animal faces to be easily injured, become ill, including which can lead to death and agrees to not hold the stable or its employees liable or responsible for any injuries and/or death, as customer already has prior knowledge to these risks as a private horse owner and understands these risks mentioned or not mentioned here within, in their entirety. Some risks may include but are not limited to sickness, severe/gas colic, additional stresses due to change in environment or feed leading to illness, injury of any kind during turnout in an unknown pasture and/or in the barn, acts of mother nature and unexpected changes in weather conditions etc. Customer agrees to pay for all damages to the stable and/or its properties that exceeds normal everyday wear and tear, caused by customer's horse(s).

Stable Owner agrees to provide the amenities as stated in chosen 'stay package', to the best of their ability provide a safe environment for customers horse(s), treat their horse(s) with kindness and follow all ethical practices of horse care. Stable agrees to contact customer and/or emergency contact(s) listed immediately if there is an emergency. Customer

understands that if they and/or emergency contact(s) are not reachable during an emergency, the Stable has the right to contact the Veterinarian listed or other veterinary resources of choice, if customer's Vet is unavailable. Customer agrees to pay all additional costs and fees incurred for all emergency services and follow-up care provided. Customer will be responsible to pay for any additional expenses incurred above the regular 'stay package' pricing upon retrieval of said horse(s) at check-out.

By signing this agreement, the Customer agrees they have read all the information provided for this service here within as well as additional detailed information on www.sonnydazeranch.com website, to include but not limited to charges for early check-ins and late check-outs/refunds/cancellations/rescheduling/additional fees for additional services etc.
