HOURS OF OPERATION: MONDAY & THURSDAY 6 PM - 9 PM (DOORS OPEN 5:30 PM, NO ADMITTANCE AFTER 8:30 PM) MRAPC MEETINGS HELD 2ND AND 4TH Tuesdays OF THE MONTH AT INDOOR RANGE AT 7 P.M.

RANGE LAYOUT:

SAFE AREA (NO AMMO) / FIRING LINE / TARGET AREA / CEASE FIRE LIGHT / EXITS / FIRST AID / FIRE EXTINGISHERS

SAFETY RULES:

- ALWAYS
 - KEEP MUZZLE POINTED IN SAFE DIRECTION (DOWN RANGE!)
 - KEEP FINGER OFF TRIGGER AND OUTSIDE TRIGGER GUARD TIL READY TO SHOOT
 - KEEP FIREARM UNLOADED UNTIL READY TO SHOOT
- NO FIREARM OUTSIDE OF SHOOT STALL UNLESS HOLSTERS OR CASED
 - MAGAZINES CANNOT BE LOADED INTO FIREARM UNTIL IN SHOOTING STALL
- NO RAPID FIRE (2 SECONDS BETWEEN SHOTS)
- NO FOOD OR DRINK ON THE RANGE; NO OPEN TOED SHOES
- RECOMMENDED TO USE A CLEAR MUZZLE INDICATOR/SAFETY FLAG IN FIREARM WHEN NOT IN USE
- RECOMMENDED TO WASH YOUR HANDS PRIOR TO LEAVING RANGE FLOOR.

CEASE FIRE:

- ANYONE CAN CALL CEASE FIRE AT ANY TIME IF UNSAFE SITUATION OCCURS
- IF CEASE FIRE IS CALLED:
 - STOP FIRING FINGER OFF TRIGGER MUZZLE DOWN RANGE WAIT.
 - RANGE SAFETY OFFICERS WILL CALL OUT INSTRUCTIONS

FIRING LINE COMMANDS:

COMMENCE FIRING / CEASE FIRE / STOP / MAKE SAFE AND SHOW CLEAR

PARTICIPANT RESPONSIBILITIES:

- ALL SHOOTERS:
 - MUST SIGN IN AT DESK AND GET LANE ASSIGNMENT
 - WAIT FOR CLEARANCE TO ENTER RANGE FROM RANGE SAFETY OFFICERS
 - NEW / INEXPERIENCED SHOOTERS MUST NOTIFY RANGE SAFETY OFFICERS

PERMITTED FIREARMS AND AMMUNITION:

- PISTOL CARTRIDGE STRAIGHT WALL CASINGS ONLY
 - 17 RIMFIRE * 22 SHORT/LONG/LONG RIFLE/MAG
 - 25 AUTO / 32 AUTO / .327 FEDERAL MAG
 - o .380 / .38 SPECIAL
 - 9MM / 40 S&W / 44 SPECIAL / .45 ACP / .45 COLT
- NO HOLLOW POINTS * NO WAD CUTTERS / SEMI-WAD CUTTERS
 - **ALL PARTICIPANTS HAVE THE RESPONSIBILITY TO ENSURE SAFETY AT MRAPC*
 THE RANGE SAFETY OFFICERS HAVE FINAL SAY ON ANY DISCREPENCIES WHILE ON THE RANGE FLOOR
