
- o The president, Dayanand (Atul) Deshpande has taken pro-active initiatives, shown leadership and provided guidance. Thank you Atul.

- o Effective use of online meetings


- o Effective use of Google Forms to register event interests

3. Treasurer's Report

- WMAI Treasurer Abhishek Joshi presented Treasurer's Report
 - o Despite 2021-2022 continue to being a challenging year in the wake of Covid19 pandemic, WMAI did manage to host 3 events and 4 movie screenings during the year with great success. Thanks to the support of the community.
 - o WMAI has consistently maintained healthy reserves enabling to spend more on key elements of event planning like selection of right venues, providing good catering, proving quality sound systems etc to be able to host successful events.

- o WMAI also facilitated Monetary Covid support to India from our community to the appropriate authority in India (PM CARES fund)
- o This year we had 26 new people join the WMAI member's club showing growing support to WMAI in turn helping WMAI to organise more such events
- o Maintain regular account keeping
- o Maintain and control payment details per event
- o File IRD and Companies office returns on a regular basis
- o Provide regular monetary benefits to members per even

4. Membership fees review

All attendees agreed to the increase of membership fees from \$11 to \$15. The rationale behind the increase is

- increased inflation
- build surplus for future that could be used for
 - o non movie events
 - buy mike/sound equipment (infrastructure costs)
 - organising special events like sponsoring of Indian/Maharashtrian celebrities

5. Elect new committee members for replacing existing resigning members

Due to some personal circumstances, Girija Deshpande and Sushant Thatte have decided to discontinue as committee members for the next year.

Makarand Velhal was invited earlier this year to help the existing committee as Varsha Vadnekar is also away overseas in India. He has already helped the committee to carry out its activities during the last two movie events and has been ratified as a replacement for Girija. All attendees accepted Makarand Velhal as committee member.

This still left one vacant position within the committee.

All attendees agreed to amend the existing constitution of how to elect new members as below:

'Existing committee can appoint / co-opt new members in the event when an existing member resigns for the remainder of the term'.

Accordingly, all attendees agreed to accept self nominees Sayali Narawade and Madhurika Kulkarni as new committee members.

4. Review Constitution Rules

It has been a while since the constitution rules have been reviewed. Committee to review the constitution rules and identify any amendments if required.

WMAI AGM meeting concluded at 5.00pm.
