FIRST AMENDMENT TO THE AMENDED AND RESTATED BYLAWS

LAKE LIVINGSTON VILLAGE IMPROVEMENT ASSOCIATION, INC.

THE STATE OF TEXAS \$

WHEREAS, Lake Livingston Village Improvement Association, Inc. (the "Association") is the governing body for the Lake Livingston Village subdivision of Polk County, Texas;

WHEREAS, the Association is subject to the Amended and Restated Bylaws of Lake Livingston Village Improvement Association, Inc. ("Bylaws"), adopted on June 5, 2021, and filed of record in the Real Property Records of Polk County, Texas, at file number 2021-2342-122; and

WHEREAS, pursuant to Article V of the Bylaws, a quorum of the Board of Directors met and voted to amend the Bylaws; provide that they may be amended by a majority vote of the Board of Directors:

NOW, THEREFORE, pursuant to the authority granted to the Board of Directors, the Bylaws are hereby amended as follows:

The portion of Article III, titled "Board of Directors," which reads, "The number of Directors may be increased or decreased by resolution of the Board; provided however, that the number of Directors shall not be reduced to less than five (5) nor increased to more than nine (9)," is hereby STRICKEN.

The portion of Article HI. Section 4, titled "Vacancies," which reads, "Any vacancy on the Board caused by death, disability, resignation, or increase in the number of Directors shall be filled by majority vote of the remaining Directors thereof, even though they may constitute less than a quorum," shall be REVISED to state, "Any vacancy on the Board caused by death, disability, or resignation shall be filled by majority vote of the remaining Directors thereof, even though they may constitute less than a quorum."

Article MI, Section 6, titled "Removal" is hereby STRICKEN in its entirety and replaced as follows:

(a) Any Director may be removed from office with or without Cause at a special meeting of the Members called for that purpose upon affirmative vote of a majority of the Members of the Association. Any Director removed in such manner shall be replaced to serve the remaining term of the removed Director

upon a majority vote of the Members present at a special meeting of the Members called for that purpose, which may occur at the same date, time, and place as the special meeting of the Members to remove a Director. (b) Any Director may be removed for Cause at a special meeting of the Board of Directors called for that purpose upon affirmative vote of a majority of the Directors. Any Director removed in such manner shall be replaced to serve the remaining term of the removed Director upon a majority vote of the remaining Directors even though they may constitute less than a quorum. For purposes of this Article IM, Section 6(b), "Cause" shall mean: (i) conviction of a felony involving moral turpitude; (ii) theft of Association funds or other property, provided such theft is reported to law enforcement by one or more Directors under penalty of perjury; or (iii) failure to attend three consecutive regular meetings of the Board of Directors.

Nothing herein is intended to alter, modify, or amend the Bylaws except as specifically provided herein.

This First Amendment to the Amended and Restated Bylaves of Lake Livingston Village Improvement Association, Inc., was properly adopted as of the 25 day of MARCH.

2023, by a vote of a majority of the Board of Directors at a duty called meeting of the Board of Directors at which a quorum was present.
