THIS THIRD AMENDMENT TO THE DECLARATION OF COVENANTS, RESTRICTIONS AND EASEMENTS FOR VOYSEY @ ALPHARETTA DOWNTOWN ("Third Amendment") is made as of the _______ day of ________ 2021 ("Effective Date"), by VOYSEY COMMUNITY ASSOCIATION, INC., a Georgia nonprofit corporation ("Association").

WITNESSETH

WHEREAS, Newhall Land Co., a Georgia corporation, as Declarant, recorded that certain Declaration of Covenants, Restrictions and Easements for Voysey @ Alpharetta Downtown on June 2016, 2016, in Deed Book 56303, Page 248 et seq., of the Fulton County, Georgia land records (hereinafter, as may be amended and/or supplemented from time to time, the "Declaration"); and

WHEREAS, the Association is a nonprofit corporation organized under the Georgia Nonprofit Corporation Code to be the Association named in the Declaration to have the power and authority set forth therein; and

WHEREAS, pursuant to Article XII of the Declaration, after the termination of the Development Period, the Board of Directors, without the vote of the Members, may amend this Declaration for the sole purpose of electing to be governed by the provisions of the Georgia Property Owners' Association Act, O.C.G.A. § 44-3-220 et seq.; and

WHEREAS, the Development Period has terminated; and

WHEREAS, the Association, acting through its Board of Directors, desires to amend the Declaration for the sole purpose of electing to be governed by the provisions of the Georgia Property Owners' Association Act, O.C.G.A. § 44-3-220 et seq.; and

WHEREAS, attached hereto as Exhibit "A" and incorporated herein by reference is the sworn statement of the Secretary of the Association, which sworn statement certifies that the approval of the Board of Directors was lawfully obtained.

NOW, THEREFORE, the undersigned hereby adopt this Third Amendment to the Declaration, hereby declaring that all the property now or hereafter subject to the Declaration shall be held, conveyed, encumbered, used, occupied and improved subject to the Declaration, amended as follows:

1.

Article II of the Declaration is hereby amended by adding the following new Section 8 to the end thereof:

Section 8. Submission to Georgia Property Owners' Association Act; Conflict. The real property now or hereafter subject to the Declaration shall be held, conveyed, encumbered, used, occupied and improved subject to the Georgia Property Owners' Association Act, O.C.G.A. Section 44-3-220 et seq. (the "Act"), as the Act may be amended from time to time. In the event of a conflict between the provisions of this Declaration and the provisions of the Act, then to the extent that the provisions of the Act cannot be waived by agreement, the Act shall control.

2.

Unless otherwise defined herein, the words used in this Third Amendment shall have the same meaning as set forth in the Declaration.

3,

This Third Amendment shall be effective only upon being recorded in the records of the Clerk of Superior Court of Fulton County, Georgia.

4.

Except as herein modified, the Declaration shall remain in full force and effect.
