## Park Manager Projects:

- Motion sensing hand dryers installed in Nature Center bathrooms

- Aquatic invasive species tank is up and running. Rusty crayfish in tank. Mussels have not survived, and waiting for Gobies. Both species are being sought.

- Wendy Wagner will create interpretive signs to educate visitors on invasive species.

## Native American Village Repair:

- The Forest Band of Potawatomi toured the Native American Village. Tribal members offered to stay in touch and help rebuild birch wigwams next spring.

- John Bagnall and Sarah will make new fish trap for Middle Woodland display in off season.

## Brachiopd Trail and ADA Parking Lot:

- We are clear to proceed with the ADA parking lot. Jessica will provide dimensions so we can draw up plans.

- We have the go-ahead for the Brachiopod Trail reroute funding. Jessica is working on plans for this project.

## Cave Point Trail:
