1. Hourly Rates

- Business & Administrative Consulting — \$50/hr
- Court-Process Consulting — \$65/hr
- Emergency / Rush Work — \$85/hr

2. Court-Process Packages

- Custody Packet Organization — \$150
(Full document sort, labeling, timeline, checklist.)
- Evidence Binder Prep — \$125
(Photos, messages, logs, statements, tabbed and organized.)
- Court-Readiness Coaching — \$75
(1 hour session on expectations, preparation, and organization.)
- Form Completion & Filing Guidance —
\$60 per set

Administrative support only — no legal advice.

3. Retainer Options

- Court-Process Retainer — \$250/month
- Business Support Retainer — \$300/month
- Premium Retainer — \$500/month

4. Add-On Fees

- Printing & Binder Prep — \$10–\$25
- Mileage — \$0.65/mile
- After-hours work — +\$20/hr

- * My hourly rate is \$50 for business consulting and \$65 for court-process consulting.
- * I also offer flat-rate packages and monthly retainers if you prefer predictable pricing.

Project Coordination & Contractor Matchmaking — Pricing

1. Contractor Matchmaking Fee

This covers finding the right contractor, vetting them, confirming availability, and connecting them with the client.

- Standard Matchmaking — \$75 per contractor match.

Includes:

- Understanding the client's project
- Matching them with a qualified contractor
- Intro + contact exchange
- Basic project outline

- Premium Matchmaking — \$150

Includes:

- 2–3 vetted contractor options
- Scheduling estimates
- Helping the client compare bids
- Project scope clarification

2. Project Setup Fee

This is for when you help the client get the project started correctly.

- Small Project Setup — \$75
(Handyman jobs, small repairs, single-day tasks)

- Standard Project Setup — \$200
(Room updates, flooring, painting, small remodels)

- Major Project Setup — \$350
(Full remodels, additions, multi-contractor jobs)
- Includes:

Scope clarification
Material list assistance
Scheduling
Communication setup
Basic timeline

3. Project Coordination (Hourly & Weekly)

Hourly Option

- \$55/hr — Project Coordination• Communication between client & contractor
- Scheduling
- Progress check-ins
- Material tracking
- Issue resolution
- Documentation

Weekly Option

- \$150/week — Light Coordination
1–2 check-ins, communication support, timeline tracking.
- \$300/week — Full Coordination
Daily check-ins, scheduling, updates, problem-solving, documentation.

4. Percentage-Based Option

- 10% of project cost — Coordination Only
- 15% — Coordination + Matchmaking + Setup

5. Add-On Fees

- Material Pickup — \$25 + mileage
- Additional Site Visit — \$40 per visit
- After-hours communication — +\$25
