Dog Training agreement

Dog Training Contract and Agreement

This Dog Training Contract and Agreement ("Agreement") is entered into between Pawsitive PAC Creations (referred to as "Trainer") and the client (referred to as "Client") as of the date of signing.

1. Services: Trainer agrees to provide dog training services to Client as described in the training plan agreed upon by both parties. The training plan may include, but is not limited to, obedience training, behavior modification, and socialization.

5. Dog Health and Vaccinations: Client represents that their dog is in good health and has received all necessary vaccinations as required by law. Trainer reserves the right to refuse training services if the dog shows signs of illness or aggression.

6. Liability: Client acknowledges that training sessions may involve physical activity and interaction with other animals. Client assumes all risks associated with the training and agrees to hold Trainer harmless from any claims, damages, or liabilities arising from the training sessions or the behavior of their dog.

7. Ownership and Control: Client retains full ownership and responsibility for the dog throughout the training program. Trainer will not assume any ownership rights or control over the dog unless explicitly agreed upon in writing.

8. Confidentiality: Trainer agrees to keep all information shared by Client confidential, except as required by law or to prevent harm to the dog, other animals, or individuals. Client agrees not to disclose any training techniques or materials provided by Trainer to any third parties without prior written consent.

9. Termination: Either party may terminate this Agreement with written notice if the other party breaches any material term of this Agreement. In the event of termination, Client will remain responsible for any outstanding fees for services rendered prior to termination.

10. Entire Agreement: This Agreement constitutes the entire understanding between Trainer and Client and supersedes any prior discussions, negotiations, or agreements, whether oral or written.

11. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the jurisdiction in which Trainer is located.
