#### DAM COMMITTEE



The dam could be considered the most critical component of our community as it creates the lake that we all enjoy. The Dam Committee is responsible for compliance with Oklahoma State and City of Oklahoma City requirements including an annual inspection and report to the Oklahoma Water Resources Board by a registered engineer, an Emergency Action Plan, and notification to Oklahoma City

Emergency officials if there is a potential dam event that could result in significant downstream flooding. The committee also evaluates and recommends reserve funds to the Board of Directors for future maintenance projects and potential emergency use.

The Dam Committee has the responsibility for maintenance of the dam, weir boards, spillway, and the six flood control gates and oversees the fiveyear plan to lower the lake for repairs. When the lake is lowered many residents will have an opportunity to repair their personal docks. The steel pins supporting the weir boards are designed to bend under high flooding waters, releasing water to prevent the water from breeching the earthen dam. The six flood control gates are installed to release water directly from the lake to avoid damage to the pins. This activity involves the most time and effort on the part of the Dam Committee members. It involves monitoring predicted rainfall events and the resulting changes in the lake level in an effort to determine when it is necessary to open some or all the floodgates. Once the rain threat passes the members close the gates in an effort to prevent the lake level going too low. Debris frequently must be removed before the gates are returned to their fully closed positions.

Much respect and gratitude are given to this important committee.

### WATERCRAFT AND LAKE SAFETY COMMITTEE



The Watercraft and Lake Safety Committee is responsible for developing the rules and regulations for both the watercraft placed on the lake by Ski Island Lake Club members and the proper use of the lake to promote safety for everyone. Oklahoma State rules and practices for watercraft are a consideration of the committee. Special training by the committee is provided for watercraft operating on a relatively

small lake which can introduce unique situations not often encountered on larger lakes.

Watercraft placed on the lake must be registered by inspection and approval by the Lake Safety Committee prior to placing the watercraft on the lake. Residents considering or having watercraft on the lake should become familiar with the Rules and Regulations for the watercraft and its operations. Contact any committee member for coordinating approvals and information.

#### **ARCHITECTURE COMMITTEE**



The Ski Island Lake Club, like other homeowner associations, is developed to enhance community living and promote the value of our properties. The Architecture Committee is responsible for overseeing the review and approval for all construction and renovation projects and ensuring that proposed projects align with community guidelines, regulations, and aesthetic standards. Residents anticipating projects for

exterior home remodeling, new structures, and fences should contact a member of the Architectural Committee for their review and approval.


### SOCIAL COMMITTEE

The Policy Committee authors and monitors the policies, recommending new policies and changes for Board consideration.

Members are encouraged to become familiar with both the


policies of the Board of Directors and the suggested guidelines for actions and courtesies by Club members for creating good-will within the Ski Island Lake community.

### **CAPITAL IMPROVEMENTS COMMITTEE**



Enhancing the Ski Island Lake community by improving our infrastructure and visual amenities is a foundation for contributing to the overall well-being and property values of the residents. The Capital Improvements Committee considers medium and long-range planning for projects, such as, landscape and beautification, wayfinding signage, and uniform graphics. Suggestions and input for project opportunities are encouraged and should be brought to the attention of committee members

### **GROUNDS AND PARKS COMMITTEE**



Maintenance, enhancement, and beautification of the community's common areas, parks, and outdoor spaces is the responsibility of the Grounds and Parks Committee. They administer contracts for mowing, landscaping, and repairs associated with the grounds, manage beautification projects, and ensure the overall well-being of the community's landscape environment. The Grounds and Parks Committee coordinates with the Social Committee for special

events, for example, a clean-up-day project for the neighborhood. Maintenance of the fountains in the lake are often undertaken by the Grounds and Parks Committee.


### LAKE AND SHORELINE COMMITTEE



The quality of our lake water and shoreline is essential to maintaining appearance and a safe recreational environment. The Lake and Shoreline Committee is responsible for water quality testing to monitor ecoli levels for the safety of those using the lake. Additionally, this committee is responsible to control the beaver population and provide fish management for sport fishing and leech control. While a

significant length of shoreline is maintained through the Dam Committee and resident's personal docks and lake walls, there remains the shoreline along South Shore Drive, the east lake wall parallel to MacArthur Boulevard, and the boat access ramp that requires weed control and periodic repairs.

#### **ISLANDS COMMITTEE**



The maintenance of the two islands which give rise to the name Ski Island Lake are managed and maintained by the Islands Committee. Their tasks include landscape, mowing, shoreline management, and structural maintenance of the gazebo. The islands are available for use by Ski Island Lake residents and questions related to special scheduling of events should be addressed to members of the Islands Committee.

#### STREETS COMMITTEE



The Ski Island Lake Club membership consists of 137 residences within four different Ski Island Lake Additions: Section 1 has 59 residences, four of which have lake access but do not have lakefront property; and Sections 2, 3, and the part of Section 5 having lake front property have 78 residences. Section 1 was developed in 1958 before being annexed into the City of Oklahoma City and did not originally have

curbs and gutters. These streets are private Ski Island Lake Club streets. All other streets in Section 2, 3, and 5 were developed after annexation, have curbs and gutters, and are public streets.

The Streets Committee is to coordinate with the City of Oklahoma City for public street maintenance opportunities and potential public funding venues. The committee is to address the maintenance and funding of our private streets via grants, Club reserves, and other options.
