Drought Funding Available

Headgates, Flumes & Pipes

ECCD has been awarded more funding to participate in the CDA's Agricultural Drought Resliency Program to help Colorado anticipate, prepare for, mitigate and adapt to drought or climate related issues.

ECCD is extending the application deadline to Eagle County residents, awarding up to \$10,000 for agriculture irrigation upgrades on *headgates, flumes and/or pipe.*

Cattle Ranches go Virtual in Eagle County

Conservation Innovation Grant in Action



Awarded the Conservation Innovation Grant through the NRCS, the Eagle County Conservation District (ECCD) will begin to introduce virtual fencing to local cattle ranches. Founded to improve the availability of sustainable animal protein, the ECCD has teamed up with Vence Corp to administer a relatively new and innovative technology in the ranching world.

Using a wireless network of GPS communication data, ranchers can place an invisible fence around livestock with versatile boundaries from a computer or smartphone with ability to monitor their cattle 24 hours a day. It gives livestock producers tremendous flexibility in how they manage and control the movement of their herds across rangelands to help promote rotational grazing. The cattle are trained to wear GPS-equipped collars that emit sensory sounds alerting the cattle when approaching boundary lines to avoid an electric stimulus.

During the 3-year study, ECCD will be examining the effectiveness of the technology and will be monitoring for rotational grazing, cattle exclusion and containment, forage productivity, and vegetative

and riparian health assessments. ECCD will also be examining the cost comparison of virtual fencing vs. physical to identify the return of investment and potential opportunities to eliminate fences in the future.

The USFS and BLM have been working diligently with VENCE and future cattle ranchers within the Eagle County boundary in kickstarting this technology and ECCD is excited to continue building on those collaborative efforts with more funding. At this time, ECCD is looking for interested ranchers to participate in the program. Funding will be provided for towers to cover each participants allotment and all collars for cattle. Training will be provided each year and participants will be expected to work with ECCD and CSU Extension's with research, design and findings.

ECCD will also be hiring two summer technicians to provide field work to collect baseline data, vegetation trends and overall evaluations of the technology for use in our region.
