Open Space & Natural Resources Introductions

- Update on a prior meeting with Ken, Laura, Marcia, Kallie:
 - Discussed ways we can work together, and be better partners with the county.

- Evolution in the county, changing priorities and bringing in programs that have been disconnected previously, to work together.
- Natural Resource branch was created, and Marcia was brought on as the director, to combine goals and programs to address both open space and natural resource management and issues.
- Still a lot of questions and evolution in the role that this program plays, as to not duplicate service provided
 - 2024 natural resource plan
- Looking for gaps, and where they can step in to fill those roles.
- Laura is meeting with Kallie to discuss scope of work, and reporting to the county.

Public Relations + Mill Levy Update

- Over the past year, a lot of outreach has been conducted with individuals and organizations to determine who the key players are, needs are:
- 1. Road Map
- Mapped out a strategic path to determine what we can accomplish, who we need to work with, what we can provide, expanding the focus to more mainstream.
- Recommendations more collaboration with partners (agrivolatic, HOA turf removal, etc), more mainstream, more visible:
 - Enhance communication:
 - Streamline our language of communication
 - Updating marketing materials
 - Education (Increase visibility)
 - Master calendar
 - Determine audience
 - Determine what we educate on, and why
 - Extend collaboration and technical assistance
 - Focus less on building projects, provide more technician assistance
 - Top 5 entities
 - Leverage board's network and power
 - Repositioning district
 - Programs, demo sites, workshops, services, community engagement
 - Funding
 - Internal capacity \$20,000 OR \$2/3K for grant writing professional
 - Rebranding professional ?
 - Mill Levy Expenses \$100,000

Seed + Wildflower Mix:

- Grass seed purchase page is live.
- Lots of interest in wildflower mixes, from the town of eagle, etc.
 - We would order in bulk.
 - Will get a quote from Pawnee Butte, Laura will send it out once she gets it.
- Would like to work closer with the county to provide resources/cross promote.

VENCE Technician Updates

- 3 new producers are under contract.
- 3000 new collars sent out from VENCE.
- Hosting two workshops one in carbondale with new producers, one locally with existing producers (April 4th) w/ grazing management plans.
- Went through interviews this week, 3 good candidates, and Ashlee from CSU would like to come back as well.
- One CSU intern applied, and the position was extended to her.

STAR Updates

- 1. New Producers
 - Funding availability for ECCD to add on three new participants.
 - Need to secure participants must be new, cannot be existing.
 - Limited time to find participants by the end of the month.
- 2. Zero Foodprint
 - STAR participants can apply to this application, and will provide the same financial benefits to a second field.
- New soil moisture probes will be installed in June this summer.

America the Beautiful Challenge (Nox Weeds) Update:

 The working group has finalized the Noxious Weed Cost Share Application and is looking good and ready to go for when we go into contract.

- 2 step process, website will help guide through it.
- Need an on-site visit before applying for cost-share.
- Patty is unsure when we will be going under contract, so cannot advertise yet.
 - May not be able to offer this year, or at all this spring.

Beyond Lawn

- The Waternow Alliance Accelerator grant was approved to help with program development.
- We will be engaging in outreach this year, not jumping in too quickly to the rebates as we build out the program with invested stakeholders.

NRCS Report:

- Snow report: 119% upper colorado headwaters, 107% median for Eagle River
 - State is looking 110% of normal, west of the divide
- Stephen is back in action starting new week
 - Soil conservation posting out, for recent grads
 - Engineer position is next to fill
- 52 total EQIP application, 17 in Eagle County
 - 14 eligible in Eagle County
- IRA funding coming down, EQIP side has to include "climate smart" mitigation practices
 - CSP and EQIP applications now

- Application for accounting technician position (admin tech) is open sent email
- Upcoming short course on animal handling and the effect of yield sent email
